The Riverside County Water Task Force is a pro-active, regional forum for the District, the County, water agencies and other stakeholders to discuss key water related issues and develop regional solutions. Most notably, the Task Force developed a groundbreaking Water Efficient Landscape Ordinance that was adopted by the County in December 2006. The Water Task Force is an essential vehicle to coordinate on-going outreach efforts to encourage water conservation, establish retrofitting programs and guide our regional responses to key State issues - all of which mesh with the District's mission and mandate.
