BACKGROUND: The Riverside County Network, a part of the Riverside County Library System, provides automation services to several independent but cooperating libraries within Riverside County. The services are arranged by the County Librarian and maintained with oversight by the County Librarian. Agreements for these services have been in place since 1997. This agreement keeps the same terms and cost, and extends the agreement for an additional year to June 30, 2011, at a cost of \$65,505. This agreement has been reviewed by County Counsel.
