BACKGROUND: On May 4, 2010 (3.66), the Board of Supervisors accepted the FY 09 Anti-Drug Abuse (ADA) Recovery Act Program and California Multi-Jurisdictional Methamphetamine (Cal-MMET) Recovery Act Program awards in the amounts of \$492,869 and \$377,000, respectively, and approved and directed the Auditor-Controller to make budget adjustments to the Sheriff's Department budget to appropriate the funds in FY 09/10. The award was finalized after the preparation and submittal of the FY 10/11 budget. These appropriations will allow the Department to utilize the grant funds intended for FY 10/11.
