

**BACKGROUND:**

The American Red Cross- Coachella Valley Disaster Operations provides shelter, food, and essential supplies to families and individuals who are displaced due to fires and other disasters.

Jordan Outreach Ministries operates the Kids Klub after school program for children ages 5 through 18. The program offers a variety of enriching activities, including: Study Klub, sports, computer center activities and learning, arts and crafts, and other age appropriate activities. It targets and serves children from Indio, Coachella, Thermal, Mecca and the outlying unincorporated areas of the county.
