



BACKGROUND:

The Coachella Valley Association of Governments (CVAG) Homelessness Committee will be purchasing bus passes from the Sunline Transit Agency for the benefit of local homelessness service providers. The CVAG Homelessness Committee believes that it is necessary for each city and the county to provide financial contribution to create a program that will support the worthwhile work of non-profit service providers. Clients will be able to utilize the Sun Bus to access supportive services, seek employment, and other essential services.

The City of Palm Springs Office of Sustainability is hosting its Third Annual Sustainability Summit on November 4th. This educational event for the community will inform the public of their role in climate change and gather input regarding climate actions.

The Salton Sea History Museum is raising funds to purchase supplies and equipment necessary to preserve, catalog, and store historical items and exhibit them for public display.

The Riverside County Peace Officer Memorial Foundation is a non-profit organization that honors Riverside County's peace officers who have died in the line of duty serving the County, State and Federal law enforcement agencies. It also provides maintenance and upkeep for current and future memorial sites.

We would like to use Fourth District Community Improvement funds to assist these organizations.
