- 3. The owner be ordered to ascertain the existence or non-existence of asbestos containing materials in said structures by survey and materials sample testing through the Industrial Hygiene Specialist of the County Health Department, Division of Special Services; and, prior to the abatement ordered in paragraph number two (2) above, to secure the removal and disposal of all asbestos containing materials discovered through such survey and testing by contract with a duly certified and licensed contractor for the handling of such materials to avoid citations and/or fines imposed by the South Coast Air Quality Management District (SCAQMD) pursuant to SCAQMD Rule No. 1403.
- 4. If the owner or whoever has possession or control of the real property does not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent of the owner or receipt of a Court Order authorizing entry onto the real property when necessary under applicable law, shall abate the substandard structure and contents therein, by removing the same from the real property.
- 5. The reasonable costs of abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Ordinance No. 725.
- 6. County Counsel be directed to prepare the necessary Findings of Facts and Conclusions that the substandard structure on the real property is declared to be in violation of Riverside County Ordinance No. 457 and a public nuisance, and further, to prepare an Order to Abate for approval by the Board.

BACKGROUND:

- 1. An inspection was made of the subject property by the Code Enforcement Officer on August 28, 2009. The inspection revealed a substandard structure (barn) on the subject property in violation of Riverside County Ordinance No. 457 (RCC Title 15). The substandard conditions of the structure included, but were not limited to, the following: lack of required electrical lighting; hazardous wiring; members of walls, partitions, or other vertical supports that split, lean, list or buckle due to defective material or deterioration; faulty weather protection; general dilapidation or improper maintenance.
- 2. Follow-up inspections on November 30, 2009, February 10, 2010, March 17, 2010, May 19, 2010, June 25, 2010, July 16, 2010 and October 5, 2010, revealed that the property continues to be in violation of Riverside County Ordinance No. 457.
- 3. Staff and the Code Enforcement Department have complied with the notice requirements set forth in the appropriate laws of this jurisdiction pertaining to the administrative abatement proceedings for substandard structures.

DECLARATION OF OFFICER RONALD WELCH

[R.C.O. No. 457, RCC Title 15]

I, Ronald Welch, declare:

- 1. I am currently employed by the Riverside County Code Enforcement Department as a Code Enforcement Officer. My current official duties include inspecting property for violations and enforcement of the provisions of Riverside County Ordinances. The following facts contained within this declaration are within my personal knowledge except to the extent that certain information is based on information and belief and if called as a witness in this matter, I could and would competently testify thereto.
- 2. On August 28, 2009, I conducted an initial inspection of the real property known as 20125 Bibbins Drive, Perris, in the unincorporated area of Riverside County, California, which is further described as Assessor's Parcel Number 322-040-023 (hereinafter described as "THE PROPERTY"). A true and correct copy of a Thomas Brothers map page indicating the approximate location of THE PROPERTY is attached hereto as Exhibit "A."
- 3. A review of County records and documents disclosed that THE PROPERTY was owned by Federal National Mortgage Association at the time of the inspection referenced in paragraph 2 above (hereinafter referred to as "OWNER"). A certified copy of the County Equalized Assessment Roll for the year 2009-2010 and a report generated from the County Geographic Information System ("GIS") are attached hereto as Exhibit "B" and incorporated herein by reference.
- 4. Based on the Lot Book Report from RZ Title Service on March 23, 2010, it is determined that one other party potentially holds a legal interest in THE PROPERTY, to wit: Great Pacific Money Markets, Inc. (hereinafter referred to as "INTERESTED PARTY"). A true and correct copy of the Lot Book Report is attached hereto and incorporated herein as Exhibit "C."

- 5. On August 28, 2009, I arrived at THE PROPERTY to conduct an initial inspection of THE PROPERTY. THE PROPERTY was vacant, open and accessible with no signs restricting access. I observed the following conditions as described below which caused the barn to be substandard and THE PROPERTY to constitute a public nuisance in violation of the provisions set forth in Riverside County Ordinance 457, as codified in Riverside County Code Title 15.
 - 1) Lack of required electrical lighting;
 - 2) Hazardous wiring;
 - Members of walls, partitions, or other vertical supports that split, lean, list or buckle due to defective material or deterioration;
 - 4) Faulty weather protection;
 - 5) General dilapidation or improper maintenance.
- 6. A Notice of Violation, Notice of Defects and "Danger Do Not Enter" sign was posted on THE PROPERTY on August 28, 2009.
- 7. On September 1, 2009 and May 27, 2010, a Notice of Violation and Notice of Defects was mailed to OWNER and on May 27, 2010 was mailed to INTERESTED PARTY by certified mail, return receipt requested.
- 8. A site plan and photographs of the condition of THE PROPERTY are attached hereto and as Exhibit "D" and are incorporated herein by reference.
- 9. True and correct copies of each Notice issued in this matter and other documentation are attached hereto as Exhibit "E" and incorporated herein by reference.
- 10. On November 30, 2009, February 10, 2010, March 17, 2010, May 19, 2010, June 25, 2010, I conducted follow up inspections of THE PROPERTY. During each inspection THE PROPERTY was open and accessible and I observed that THE PROPERTY remained unchanged and in violation of Riverside County Ordinance No. 457 (RCC Title 15).
- 11. I am informed and believe and based thereon allege that on July 16, 2010, Code Enforcement Officer Diaz conducted a follow-up inspection of THE PROPERTY. Officer Diaz observed that THE PROPERTY continued to remain in violation of Riverside County Ordinance No. 457 (RCC Title 15).
- 12. Based upon my experience, knowledge and visual observations, it is my determination that the substandard structure (barn) on THE PROPERTY creates an extreme health, safety, fire and structural

hazard to the neighbors and general public.

- 13. A follow-up inspection on October 5, 2010 showed THE PROPERTY remained in violation of Riverside County Ordinance No. 457 (RCC Title 15).
- 14. Furthermore, based on my observations of THE PROPERTY, I declare that the substandard conditions of THE PROPERTY constitute a public nuisance in violation of the provisions set forth in Riverside County Ordinance No. 457 (RCC Title 15).
- 15. A Notice of Noncompliance was recorded on June 21, 2010 as Document Number 2010-0284828 in the Office of the County Recorder, Riverside County, State of California. A true and correct copy of this notice is attached hereto as Exhibit "F" and incorporated herein by reference.
- 16. On September 13, 2010, the second notice, Notice to Correct County Ordinance Violations and Abate Public Nuisance, providing the notification of the Board of Supervisors' hearing was mailed to OWNER by certified mail, return receipt requested and was posted on THE PROPERTY on October 5, 2010. A true and correct copy of the notice, together with proof of service, returned receipt card and the Affidavit of Posting of Notice are attached as Exhibit "G" and incorporated herein by reference.
- 17. Significant rehabilitation, removal and /or demolition of the substandard structure and removal and disposal of all structural debris are required to abate the public nuisance and bring THE PROPERTY into compliance with Riverside County Ordinance Number 457 (RCC Title 15), the Health and Safety, Uniform Housing, Administrative and Abatement of Dangerous Buildings Codes.
 - 18. Accordingly, the following findings and conclusions are recommended:
- (a) the structure (barn) be condemned as substandard buildings, public nuisance and attractive nuisance;
- (b) the OWNER be required to rehabilitate or demolish said structures, including the removal and disposal of all structural debris and materials, on THE PROPERTY in accordance with the provisions of Riverside County Ordinance No. 457 (RCC Title 15);
- (c) the OWNER be ordered to ascertain the existence or non-existence of asbestos containing materials in said structures by survey and materials sample testing through the Industrial Hygiene Specialist of the County Health Department, Division of Special Services; and, prior to the

abatement ordered in subsection (b) above, to secure the removal and disposal of all asbestos containing materials discovered through such survey and testing by contract with a duly certified and licensed contractor for the handling of such materials to avoid citations an/or fines by South Coast Air Quality Management District ("SCAQMD") pursuant to SCAQMD Rule NO. 1403;

- (d) if the substandard structure is not razed, removed and disposed of, or reconstructed in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance No. 457 (RCC Title 15), within ninety (90) days of the date of the Board's Order to Abate, the substandard structure and contents therein shall be abated by representatives of the Riverside County Code Enforcement Department, a contractor or the Sheriff's Department upon receipt of an owner's consent or a Court Order where necessary under applicable law authorizing entry onto THE PROPERTY;
- (e) that reasonable costs of abatement, after notice and opportunity for hearing, shall be imposed as a lien on THE PROPERTY, which may be collected as a special assessment against THE PROPERTY pursuant to Government Code Section 25845 and Riverside County Ordinance Nos. 457 and 725 (RCC Titles 15 and 1).


