The substandard structure (dwelling) on the real property located at 12070 Theodore Street, Moreno Valley, Riverside County, California, APN: 422-020-003 be declared a public nuisance and a violation of Riverside County Ordinance No. 457 which does not permit substandard structures on the property.
- 2. The Estate of Robert N. Jackson, the owner of the subject real property, be directed to abate the substandard structure on the property by rehabilitating, removing and/or demolishing the same from the real property, including the removal and disposal of all structural debris and materials within ninety (90) days.

- 3. The owner be ordered to ascertain the existence or non-existence of asbestos containing materials in said structure by survey and materials sample testing through the Industrial Hygiene Specialist of the County Health Department, Division of Special Services; and, prior to the abatement ordered in paragraph number two (2) above, to secure the removal and disposal of all asbestos containing materials discovered through such survey and testing by contract with a duly certified and licensed contractor for the handling of such materials to avoid citations and/or fines imposed by the South Coast Air Quality Management District (SCAQMD) pursuant to SCAQMD Rule No. 1403.
- 4. The accumulation of rubbish on the real property located at 12070 Theodore Street, Moreno Valley, be declared a public nuisance and a violation of Riverside County Ordinance No. 541 which does not permit the accumulation of rubbish on the property.
- 5. The Estate of Robert N. Jackson, the owner of the subject property, be directed to abate the accumulation of rubbish on the property by removing and disposing of the same from the real property within ninety (90) days
- 6. If the owner of the real property does not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent or receipt of a Court Order authorizing entry onto the real property when necessary under applicable law, shall abate the substandard structure and accumulation of rubbish by removing and disposing of the same from the real property.
- 7. The reasonable costs of abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Riverside County Ordinance No. 725.
- 8. County Counsel be directed to prepare the necessary Findings of Fact and Conclusions that the substandard structure and accumulation of rubbish on the real property is declared to be in violation of Riverside County Ordinance Nos. 457 and 541, and constitutes a public nuisance. Further, County Counsel shall prepare an Order to Abate for approval by the Board.

BACKGROUND:

- 1. An initial inspection was made of the subject real property by the Code Enforcement Officer on July 27, 2009.
- 2. The inspection revealed a substandard structure (dwelling) on the subject real property in violation of Riverside County Ordinance No. 457. The substandard conditions of the structure included, but were not limited to the following: lack of or improper water closet, lavatory, bathtub, shower or kitchen sink; lack of required electrical lighting; lack of adequate heating facilities; members of walls, partitions, or other vertical supports that split, lean, list or buckle due to defective material or deterioration, faulty weather protection; general dilapidation or improper maintenance; abandoned, vacant, public and attractive nuisance. The inspection also revealed the accumulation of rubbish (approximately 965 square feet) on the subject property in violation of Riverside County Ordinance No. 541. The accumulation of rubbish consisted of, but was not limited to the following materials: five gallon paint cans, construction waste, household rubbish, a dead coyote and green waste.
- 3. Subsequent inspections of the above-described real property on October 21, 2009, December 11, 2009, March 11, 2010, May 3, 2010, July 14, 2010 and Sept. 14, 2010, revealed that the property continues to be in violation of Riverside County Ordinance Nos. 457 and 541.
- 4. Staff and the Code Enforcement Department have complied with the requirements set forth in the appropriate laws of this jurisdiction pertaining to the Administrative Abatement Proceedings for substandard structure and accumulation of rubbish.

DECLARATION OF OFFICER JACOB DIETRICH

[R.C.O. No. 457, RCC Title 15] [R.C.O. No. 541, RCC Chapter 8]

I, Jacob Dietrich, declare that the facts set forth below are personally known to me except to the extent that certain information is based on information and belief which I believe to be true and if called as a witness, I could and would competently testify under oath:

- 1. I am currently employed by the Riverside County Code Enforcement Department as a Code Enforcement Officer. My current official duties as a Code Enforcement Officer include inspecting property for violations and enforcement of the provisions of Riverside County Ordinances.
- 2. I am informed and believe and based thereon allege that on July 27, 2009, Officer Pike conducted an initial inspection of the real property known as 12070 Theodore Street, Moreno Valley, within the unincorporated area of Riverside County, California, which is further described as Assessor's Parcel Number 422-020-003 (hereinafter referred to as "THE PROPERTY"). A true and correct copy of a Thomas Brothers map page indicating the approximate location of THE PROPERTY is attached hereto as Exhibit "A" and incorporated herein by reference.
- 3. A review of County records and documents indicate that THE PROPERTY was owned by Estate of Robert N. Jackson (hereinafter referred to as "OWNER") at the time of the inspection referenced in paragraph number 2 above. A certified copy of the County Equalized Assessment Roll for the year 2009-2010 and a copy of the County Geographic Information System ("GIS") report are attached hereto as Exhibit "B" and incorporated herein by reference.
- 4. Based on the Lot Book Report from RZ Title Company dated February 3, 2010, it is determined that additional parties potentially hold a legal interest in THE PROPERTY, to wit: State

Board of Equalization (hereinafter referred to as "INTERESTED PARTY"). A true and correct copy of the Lot Book Report is attached hereto as Exhibit "C" and incorporated herein by this reference.

- 5. I am informed and believe and based thereon allege that on July 27, 2009, Officer Pike conducted an initial inspection of THE PROPERTY on which he observed a dwelling structure in a state of general dilapidation. THE PROPERTY was unfenced, vacant with no signs posted to restrict access. I observed the following conditions which cause the structure to be substandard and THE PROPERTY to constitute a public nuisance in violation of the provisions set forth in Riverside County Ordinance 457, as codified in Riverside County Code Title 15:
 - 1) Lack of improper water closet, lavatory, bathtub, shower or kitchen sink;
 - 2) Lack of required electrical lighting;
 - 3) Lack of adequate heating facilities;
 - 4) Members of walls, partitions or other vertical supports that split, lean, list or buckle due to defective materials or deterioration;
 - 5) Faulty weather protection;
 - 6) General dilapidation or improper maintenance;
 - 7) Public and attractive nuisance abandoned/vacant.
- 6. During the initial inspection on July 27, 2009, Officer Pike also observed large amounts of accumulated rubbish on THE PROPERTY including, but not limited to: five gallon paint cans, construction waste, household rubbish, a dead coyote and green waste. The total area of the accumulated rubbish was approximately nine hundred sixty-five (965) square feet. This condition causes THE PROPERTY to constitute a public nuisance in violation of Riverside County Ordinance No. 541, as codified in Riverside County Code Chapter 8.
- 7. A site plan and photographs reflecting the substandard condition of the structure and the accumulated rubbish on THE PROPERTY are attached hereto as Exhibit "D" and incorporated herein by reference.
- 8. True and correct copies of each Notice issued in this matter and other supporting documentation are attached hereto as Exhibit "E" and incorporated herein by reference.
- 9. On July 27, 2009, Officer Pike posted a Notice of Defects, a Notice of Violations (RCC 15.16.020 Substandard Structure and RCC 8.120 Accumulation of Rubbish), a "Danger Do Not Enter" sign, and a "Do Not Dump" sign on THE PROPERTY.

- 10. On August 13, 2009, a Notice of Noncompliance for the substandard structure and accumulated rubbish was recorded against THE PROPERTY as instrument number 2009-0421079. A true and correct copy of the recorded Notice of Noncompliance is attached hereto and incorporated by reference as Exhibit "F".
- 11. On August 4, 2009, November 12, 2009, December 18, 2009 and April 9, 2010 Notices of Violations (RCC 15.16.020 Substandard Structure and RCC 8.120 Accumulation of Rubbish) were mailed by certified mail, return receipt requested to OWNER and on November 12, 2009 were mailed to INTERESTED PARTY by certified mail, return receipt requested.
- 12. I am informed and believe and based thereon allege that on October 21, 2009 and December 11, 2009, Officer Pike drove to THE PROPERTY to conduct follow up inspections. The conditions on THE PROPERTY remained the same as those which he observed on July 27, 2009. Accumulated rubbish remained on THE PROPERTY, the structure remained in a general state of dilapidation, and THE PROPERTY continued to constitute a public nuisance in violation of RCO 457 and 541.
- 13. On March 11, 2010 and July 14, 2010 I conducted follow up inspections of THE PROPERTY which was open and accessible. During my July 14, 2010 inspection, using the pacing method, I identified and measured the accumulated rubbish as three thousand nine hundred (3,900) square feet. The items consisted of, but were not limited to: green waste, tires, vehicle parts, cardboard, scrap wood and metal, concrete, plastics, miscellaneous trash and debris.
- 14. I am informed and believe and based thereon allege that on May 3, 2010, Senior Code Officer Bowles conducted a follow up inspection of THE PROPERTY which was open and accessible and noted the violations remained.
- 15. I am informed and believe, and based upon said information and belief, allege that OWNER does not have legal authority or permission to store or accumulate the above described materials on THE PROPERTY.
- 16. Based upon my experience, knowledge and visual observations, it is my determination that the substandard structure and accumulation of rubbish on THE PROPERTY create an extreme health, safety, fire and structural hazard to the neighbors and general public and


constitutes a public nuisance in violation of the provisions set forth in Riverside County Ordinance Nos. 457 and 541.

- Abate Public Nuisance" providing notification of the Board of Supervisors hearing scheduled for October 19, 2010, as required by Riverside County Ordinance No. 725, was mailed to OWNER and INTERESTED PARTY by certified mail, return receipt requested and on September 14, 2010 was posted on THE PROPERTY. True and correct copies of the notice, return receipt cards, together with the proof of service and the affidavit of posting of notices are attached hereto as Exhibit "G" and incorporated herein by reference.
- 18. A follow-up inspection on September 14, 2010 revealed that THE PROPERTY remains in violation.
- 19. Significant rehabilitation, removal and/or demolition of the substandard structure and removal and disposal of all structural materials, rubbish and debris are required to abate the public nuisance and bring THE PROPERTY into compliance with Riverside County Ordinance Number 457 (RCC Title 15), the Health and Safety, Uniform Housing, Administrative and Abatement of Dangerous Buildings Codes. In addition, the removal and disposal of all rubbish on THE PROPERTY is required to bring THE PROPERTY into compliance with Riverside County Ordinance No. 541.
 - 20. Accordingly, the following findings and conclusions are recommended:
- (a) The structure be condemned as a substandard building, public and attractive nuisance;
- (b) The OWNER, or whoever has possession or control of THE PROPERTY, be required to rehabilitate or demolish said structure, including the removal and disposal of all structural debris and materials, on THE PROPERTY in strict accordance with the provisions of Riverside County Ordinance No. 457 (RCC Title 15);
- (c) The OWNER, or whoever has possession or control of THE PROPERTY, be ordered to ascertain the existence or non-existence of asbestos containing materials in said structures by survey and materials sample testing through the Industrial Hygiene Specialist of the Riverside

SUMMARY OF EVIDENCE

- 1. Documents of record in the Riverside County Recorder's Office identify the owner of THE PROPERTY as The Estate of Robert N. Jackson. ("OWNER").
- Documents of title at the time of the inspection indicated that other parties potentially hold a legal interest in THE PROPERTY, to-wit: San Bernardino, Riverside, Orange and Los Angeles County Family Support Divisions, Canyon Lake Property Owners Association, Superior Ready Mix Concrete, L.P. and Corona Ranch Terrace Homeowners Association ("INTERESTED PARTIES").

- 6. A Notice of Noncompliance was recorded on February 22 and June 5, 2001 as Document Numbers 068702 and 250043, respectively, in the Office of the County Recorder, County of Riverside.
- 7. On August 6 and September 20, 2003, a Notice of Violation for Violation of RCO Nos. 348 and 541 was posted on the property and on September 5, 2003 said Notices of Violation were mailed to the Owner and Interested Parties respectively, by certified mail, return receipt requested.
- 8. On December 6, 2003, a "Notice To Abate Nuisance" providing notice of the public hearing before the Board of Supervisors on January 27, 2004, was mailed by certified mail, return

receipt requested, to THE PROPERTY OWNER and Interested Parties and posted on THE PROPERTY on that same date.

FINDINGS AND CONCLUSIONS

WHEREFORE, the Board of Supervisors of the County of Riverside, State of California, in regular session assembled on January 27, 2004 finds and concludes that:

- 1. WHEREAS, the excessive outside storage of materials and rubbish on the real property located 12070 Theodore Street, Moreno Valley, Riverside County, California, also identified as Assessor's Parcel Numbers 422-020-003 violates Riverside County Ordinance Nos. 348 and 541 and constitutes a public nuisance.
- 2. WHEREAS, THE OWNER AND INTERESTED PARTIES ARE HEREBY FUTHER NOTICED that the time within which judicial review of the administrative determinations made herein must be sought is ninety (90) days from the posting and mailing of the Findings of Fact, Conclusions and Order To Abate Nuisance, and is governed by <u>California Code of Civil Procedure</u> Section 1094.6.

ORDER TO ABATE NUISANCE

IT IS THEREFORE ORDERED that the excess outside storage of materials and accumulation of rubbish on THE PROPERTY be abated by THE PROPERTY OWNER, specifically The Estate of Robert N. Jackson or anyone having possession or control of THE PROPERTY, by removing and disposing of the excess outside storage of materials and accumulation of rubbish from the subject real property in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance Nos. 348 and 541 within ninety (90) days from the posting and mailing of this order.

IT IS FURTHER ORDERED that if the materials are not removed and disposed of in strict

accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance Nos. 348 and 541, within ninety (90) days of the posting and mailing of this Order, the excess outside storage of materials and accumulation of rubbish shall be abated by representatives of the Riverside County Department of Building and Safety, a contractor or the Sheriff's Department upon receipt of an owner's consent or a Court Order when necessary under applicable law.

IT IS FURTHER ORDERED that reasonable costs of abatement, after notice and opportunity for hearing, shall be imposed as a lien on THE PROPERTY, which may be collected as a special assessment against THE PROPERTY pursuant to Government Code Section 25845 and Riverside County Ordinance Nos. 348, 541 and 725.








