BACKGROUND: (Continued)

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, the Tax Collector conducted the March 13, 2006 public auction sale. The deed conveying title to the purchasers at the auction was recorded May 3, 2006. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on June 5, 2006, to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of lot book reports as well as Assessor's and Recorder's records, and various research methods were—used to obtain current mailing addresses for these parties of interest.

The Treasurer-Tax Collector has received six claims for excess proceeds:

- Claims from the Law Offices of Philip A. Putman AKA Excess Proceeds Services LLC, assignee for Paul H. Peters AKA Harold Peters III based on an Assignment of Rights to Claim Excess Proceeds from Sale of Tax Deeded Property and Declaration dated December 1, 2006, a Corporation Grant Deed recorded February 15, 1980 as Instrument No. 31795, an Affidavit Section 13101-Probate Code and the death certificate of Harold Washington Peters, Jr.
- Claims from Phillip A. Putman AKA Philip A. Putman, assignee for Lenora Peters AKA Lenora J. Peters based on Assignment's of Right to Collect Excess Proceeds dated May 22, 2008 and a Corporation Grant Deed recorded February 15, 1980 as Instrument No. 31795, an Affidavit Section 13101-Probate Code and the Dissolution of Marriage filed July 14, 1988.
- 3) Claims from the Law Offices of Philip A. Putman, assignee for Jahmal Peters based on Assignment's of Right to Collect Excess Proceeds dated October 16, 2008, a Corporation Grant Deed recorded February 15, 1980 as Instrument No. 31795 an Affidavit Section 13101-Probate Code and the death certificate of Harold Washington Peters, Jr.

Pursuant to Section 4675 (a) & (b) of the California Revenue and Taxation Code, it is the recommendation of this office that the Law Offices of Philip A. Putman AKA Excess Proceeds Services LLC, assignee for Paul H. Peters AKA Harold Peters III be denied since they were unable to substantiate their claims. The claims from Phillip A. Putman AKA Philip A. Putman, assignee for Lenora Peters AKA Lenora J. Peters and the Law Offices of Philip A. Putman, assignee for Jahmal Peters be denied since the claims were filed after the filing period. The Revenue and Taxation Code Section 4675 states that a claim must be received prior to the expiration of one year following the recordation of the Tax Collector's Deed to the Purchaser, which was on May 3, 2006. Since there are no other claimants the excess proceeds in the amount of \$16,131.20 will remain unclaimed. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimants by certified mail.

DECLARATION OF LENORA JENKINS PETERS

I, LENORA JENKINS PETERS, declare that if called and sworn to testify, I would state that:

I am the Petitioner in this action.

My ex-husband, Harold, moved out of our house at 2432

So. Halm Avenue, Los Angeles, California, over a year ago. The Respondent has been coming back and forth to my house to get his belongings. I have asked that he set one day to come and get all of his things so that he would not disturb my peace.

On Friday, June 2, 1989, Harold came by the house. I had moved the Pinto car because he refused to come and get it.

I told him that I was going to move his Thunderbird if he did not come and get it. He stated that if I did, he would kill me before the cops could get there.

On Saturday, June 10, 1989, Harold came by to get his mail and his Thunderbird. I asked him to take all of his possessions from my garage, including his junk cars. He again stated that if I moved them, he would kill me.

I have asked Harold to change his address at the post office so that he would not need to come to my house to get his mail anymore. He refuses to do so.

Later that evening, a woman called my house two (2) times for Harold, speaking to my mother and me. I did not know the woman and had not given her my number. I told her that Harold did not live there anymore and asked her not to call back. She called back twice and hung up the phone.

On Monday, June 12, 1989, Harold came by the house to get his clothes. I told him to take everything. He said "No", that

he would come by when he gets ready. This annoys me and disturbs my peace. I never know when he is coming over.

I cannot entertain my guests because he may interrupt to come and get something. His conduct is designed to annoy me and find out what I am doing - who I am dating.

On June 15, 1989, I came home. Harold was there waiting outside and insisted that I let him in to get his stereo set. I had an appointment and could not wait for him. So, I told him "No" and left. I left him standing on the lawn. When I returned home, late at night, Harold called and asked if he could come and get his stereo. I said "No" because it was late. Our son and I both had to get up early to go to school and work. A woman then came on the phone from his end and stated "Bitch, I'll see if the police won't make you find time". She then hung up. Later, the phone started to ring constantly. Wen I would answer, the caller would hang up. I believe that it was Harold and his friend. I had not experienced this problem before.

On Monday, June 19, 1989, Harold called to comy by. I told him not to come. He came anyway. He banged on my door loudly. I refused to open the door. He was so loud and noisy it disturbed my neighbors. The police arrived. This was embarassing. Harold left.

About 11:00 p.m. that evening, my phone rang. When I answered a woman's voice was on the other line. She called me "Bitches, "whores" and stated that she and Harold would come over. I hung up. The phone continued to ring until the early morning hours. Whenever I would answer, I would hear the same female voice I had heard around 11:00 p.m. After answering it a few times, I

refused to answer again. However, the ringing disturbed my rest.

I awoke the next morning very tired from lack of sleep.

Since the inception of these divorce proceedings, Harold has stated that he would "get me"; that he would "blow my head off before I could call the police". He has made statements that "I have lived my life, I don't mind dying, you will go first and I will see that the police and nobody else can save you".

I am afraid of Harold. He has made me a nervous wreck.

Harold will not give me an address nor a phone number. He will not put in a forwarding address at the post office. I want him to come and get all of his belongings at one time so that he will have no need to come to my house again.

I want him to give me a forwarding address so that I may send any mail that may come to the house for him directly to him. If he refuses to do that, I request permission to return all of his mail to the sender with an indication of "NO FORWARDING ADDRESS ON FILE".

Prior to Harold's female friend calling my house, I had not experienced repeated phone calls and hang up calls. I believe that he has given this person my number. I have had this phone number for quite some time. It would cause inconvenience to me and our son to change the number.
