SUBJECT: Notice of Nonrenewal on a portion of land subject to a Land Conservation Contract within Rancho California Agricultural Preserve No. 4, Case No. AGN00161 - Applicant: LOUIDAR, L.L.C. (Louis Darwish).

#### **RECOMMENDED MOTION:**

AUTHORIZE the owner to serve a Notice of Nonrenewal on a portion of his land subject to an existing Land Conservation Contract.

#### **BACKGROUND:**

On October 14, 1970, John Poole Radio Properties Inc., entered into a contract with the County of Riverside pursuant to the California Land Conservation Act of 1965 (Williamson Act). The subject property is located within Rancho California Agricultural Preserve No. 4, Map No. 110. This land is now under the ownership of LOUIDAR, L.L.C. Pursuant to Section 51245 of the California Government Code, the Board of Supervisors may authorize a land owner to serve a Notice of Nonrenewal on a portion of the land under a contract. LOUIDAR, L.L.C. has served notice that they intend not to renew the agricultural contract on the portion of land identified in Map 1020 (attached). In the event that the Board of Supervisors authorizes such service, the Planning Department will process and record the Notice of Nonrenewal. The Notice of Nonrenewal was submitted at least 90 days prior to the end of calendar year 2010. Consequently, a new 10 year period will not begin on January 1, 2011. The contract, as it applies to the land subject to this Notice of Nonrenewal, will expire on January 1, 2020 (the completion of the 10 year period that began on January 1, 2010), unless a cancellation is approved and finalized prior to said date.
