On November 24, 2009, the Board of Supervisors executed an agreement with CHP to provide traffic control services during the construction phase of the State Route 60/Valley Way Interchange Project. CHP traffic control services are required by Caltrans and will help to encourage motorists to drive safely through the construction zone. Construction has commenced and is on-going. The project has experienced some delay due to utility conflicts encountered during construction but is now proceeding well.

This Amendment No. 1 will extend the agreement termination date to November 30, 2010. This extension became necessary to allow CHP to continue to provide traffic control services.
