BACKGROUND:

The Economic Development Agency wishes to convey Assessor's Parcel Number 277-210-008, located at 7500 El Cerrito Road in the unincorporated community of El Cerrito, "Property" to the Redevelopment Agency for the County of Riverside. The Property was acquired by the County of Riverside through an eminent domain settlement for the construction of the El Cerrito Sports Park Project using redevelopment funds. The Board approved this action on January 12, 2010, as item B.1 in closed session.

WHEREAS, pursuant to Government Code Section 25365, with 4/5 vote, the County of Riverside ("County") may convey or otherwise transfer to any community redevelopment agency any real property or interest therein belonging to the County if the property therein to be conveyed is not required for County use;

WHEREAS, The County owns said real property and wishes to convey the parcel, known as Assessor's Parcel Number 277-210-008 ("Property,") to the Redevelopment Agency for the County of Riverside:

WHEREAS, the real property belonging to the County is not required for County use;

WHEREAS, the Redevelopment Agency for the County of Riverside ("Agency") wishes to accept from the Property located within the I-1986 Project Area conveyed by the County;

WHEREAS, the County is conveying this Property for general redevelopment purposes that will assist in implementing the redevelopment plan ("Plan") and assist in eliminating physical blighting conditions.

NOW THEREFORE, BE IT RESOLVED, DETERMINED, AND ORDERED by the Board of Supervisors of the County of Riverside, State of California, in regular session assembled November 30, 2010 as follows:

- 1. That the Board of Supervisors hereby finds and declares that the above recitals are true and correct.
- That the County of Riverside is authorized to convey real property consisting of Assessor's Parcel Number 277-210-008 located in the unincorporated
