SUBJECT: Approval of an Appropriation of Homeland Security Grant
Program Funds for Sheriff's Hazardous Device Team Purchases

RECOMMENDED MOTION: Move that the Board of Supervisors approve and direct the Auditor-Controller to make the budget adjustments on the attached Schedule A.

BACKGROUND: The Sheriff's Department is a Board-appointed member of the Anti-Terrorism Approval Authority (ATAA), and the Sheriff's Hazardous Device Team is a member of the County-wide HazMat Operations Group (CHOG). Federal pass-through funds awarded to the County under the State Homeland Security Grant Program and administered by the Community Health Agency, have been supporting CHOG drills and training for hazardous material emergencies. The ATTA has approved \$66,000 of this funding for the purchase of special bomb examination and demolition tools required by the Sheriff's Hazardous Device Team (HDT).
