SUBJECT: Construction of Landfill Gas Collection System Expansions for Fiscal Year 2010/2011 at the Badlands and Lamb Canyon Landfills

RECOMMENDED MOTION: That the Board:

1. Accept the bid submitted by BAS Construction LP in the amount of \$226,726.03 for the Construction of Landfill Gas Collection System Expansions for Fiscal Year 2010/2011 at the Badlands and Lamb Canyon Landfills; and
2. Authorize the Chairman to execute the Agreement on behalf of the Department.

BACKGROUND: The Board authorized the Waste Management Department (Department) to advertise for bids on September 14, 2010. On October 14, 2010 the Department opened bids for Construction of Landfill Gas Collection System Expansions for Fiscal Year 2010/2011 at the Badlands and Lamb Canyon Landfills. The Department received eight bids ranging from \$226,726.03 to \$460,982.50. The Engineer's estimate for this project is \$241,805.00. BAS Construction LP submitted the lowest bid of \$226,726.03. The Department has determined that BAS Construction LP has the necessary minimum experience and capability to perform this work in accordance with the contract documents. County Counsel has determined that the bid documents are in order.

AGREEMENT

THIS AGREEMENT is made as of November 30, 2010 and is between the COUNTY OF RIVERSIDE (County) and BAS Construction LP (Contractor).


IT IS AGREED BY THE PARTIES AS FOLLOWS:

1. The Work. Contractor shall furnish all tools, equipment, apparatus, facilities, labor and material necessary to perform the work for the project, Construction of Landfill Gas Collection System Expansions for Fiscal Year 2010/2011 at the Badlands and Lamb Canyon Sanitary Landfills, in exact conformity with the Contract Documents, subject to such inspection as County deems appropriate.

 - (r) Orders, instructions, drawings and plans issued by County during the course of the work in accordance with the provisions of the Contract Documents.






