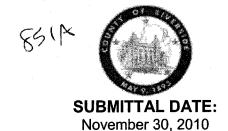

SUBJECT: Authorization to Reissue County Stale-Dated Warrants #2011 - 3

RECOMMENDED MOTION: Authorize the re-issuance of County Stale-Dated Warrants pursuant to Government Code Section 29802.

BACKGROUND:

Governmental Code 29802 requires a warrant to become void (stale-dated) if it has not been presented for payment to the County Treasurer within six months after the issuance date. Within two years from the date on which the original warrant becomes void, the payee or assignee of any warrant may request for the warrant to be reissued. Pursuant to Board Resolution 82-278 (amended Board Agenda 3.5 8/6/1996), the Board of Supervisors approval is needed for amounts \$10,000 and greater. In addition, any warrant that is older than the two-year period requires Board approval. The total amount in attachment "A" of \$443,448 represents \$35,810 in stale-dated warrants over two-years old , \$396,538 in stale-dated warrants over \$10,000 and \$11,100 in requests from departments to journal funds related to stale-dated warrants over two-years old.
