- 3. If the owner of the real property does not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent or receipt of a Court Order authorizing entry onto the real property when necessary under applicable law, shall abate the excess outside storage and accumulation of rubbish by removing and disposing of the same from the real property.
- 4. The reasonable costs of abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Riverside County Ordinance No. 725.
- 5. County Counsel be directed to prepare the necessary Findings of Fact and Conclusions that the excess outside storage of materials and accumulation of rubbish on the real property is declared to be in violation of Riverside County Ordinance Nos. 348 and 541, and a public nuisance, and further, to prepare an Order to Abate for approval by the Board.

BACKGROUND:

- 1. An initial inspection was made of the subject property by the Code Enforcement Officer on November 9, 2009.
- 2. The inspection revealed the excess outside storage of materials and an accumulation of rubbish on the subject property in violation of Riverside County Ordinance Nos. 348 and 541. The items included but were not limited to: appliances, furniture tires, pipes, pots, buckets, wood, fencing, tubs, sheet metal, garage doors, wood, cardboard, household trash, barrels, blankets, tools, bins, crates, dog houses, kennels, sheds, tarps, clothing and other miscellaneous trash and debris.
- 3. Subsequent follow up inspections of the above-described real property on March 15, 2010, April 26, 2010, June 28, 2010, October 21, 2010 and November 15, 2010, revealed that the property continued to be in violation of Riverside County Ordinance Nos. 348 and 541.
- 4. Staff and the Code Enforcement Department have complied with the notice requirements set forth in the appropriate laws of this jurisdiction pertaining to the administrative abatement proceedings for the removal of excess outside storage and accumulated rubbish.

- I, Brett Pollard, declare that the facts set forth below are personally known to me except to the extent that certain information is based on information and belief which I believe to be true, and if called as a witness, I could and would competently testify thereto under oath:
- 1. I am currently employed by the Riverside County Code Enforcement Department as a Code Enforcement Officer. My current official duties as a Code Enforcement Officer include inspecting property for violations and enforcement of the provisions of Riverside County Ordinances.
- 2. I am informed and believe and based thereon allege that on November 9, 2009, Riverside County Sheriff Deputy Whittaker and Officer Heagstedt conducted an initial inspection of the real property described as 59325 Upper Tule Fire Road, Anza, Riverside County, California and further described as Assessor's Parcel Number 579-310-038 (hereinafter referred to as "THE PROPERTY"). A true and correct copy of a Thomas Brothers map indicating the location of THE PROPERTY is attached hereto as Exhibit "A."
- Jack Ziniuk (hereinafter referred to as "OWNER"). A certified copy of the County Equalized Assessment Roll for the year 2009-2010 and a copy of the report generated from the County Geographic Information System ("GIS") is attached hereto and incorporated herein by reference as Exhibit "B." THE PROPERTY is located within the R-R (Rural Residential) zone classification. This zone classification allows outside storage on an improved parcel with the amount of storage to be one hundred (100) square feet for properties that are a minimum of one-half acre in size. THE PROPERTY is unimproved and approximately 6.52 acres. No amount of rubbish is allowed on THE PROPERTY.
- 4. Based upon the Lot Book Report issued by RZ Title Service on March 22, 2010 and updated on October 13, 2010, it is determined that other parties may potentially hold a legal interest in DECLARATION OF CODE ENFORCEMENT OFFICER 1

12/7/10 9.3

THE PROPERTY, to wit: Kenneth Carter, Lewis G. Linn and Helen L. Linn and Central Jail Bail Bonds (hereinafter referred to as "INTERESTED PARTIES"). A true and correct copy of the Lot Book Report is attached hereto as Exhibit "C" and is incorporated herein by reference.

- 5. I am informed and believe and based thereon allege that on November 9, 2009, Officer Heagstedt met Riverside Sheriff Deputy Whittaker at THE PROPERTY and conducted an inspection. From the road right of way, Officer Heagstedt observed excess outside storage in excess of two hundred square feet and accumulated rubbish on THE PROPERTY.
- 6. As a result of the excess outside storage of materials and accumulated rubbish, THE PROPERTY constituted a public nuisance in violation of the provisions set forth in Riverside County Ordinance ("RCO") No. 348 as codified in Riverside County Code ("RCC") Chapter 17.16 and RCO No. 541, as codified in RCC Chapter 8.120.
- 7. On November 9, 2009, Notices of Violation for the excess outside storage of materials and accumulated rubbish were posted on THE PROPERTY.
- 8. I am informed and believe and based thereon allege that on March 15, 2010, Officers Forrey and Heagstedt conducted a follow-up inspection of THE PROPERTY. THE PROPERTY was abandoned, open and accessible. Using the pacing method, Officer Heagstedt measured the areas of rubbish and excess outside storage and determined the amount to be thirty seven thousand six hundred (37,600) square feet. The outside storage of materials and accumulated rubbish were intermingled and consisted of but was not limited to: appliances, furniture, tires, pipes, pots, buckets, wood, fencing, tubs, sheet metal, garage doors, wood, cardboard, household trash, barrels, blankets, tools, bins, crates, dog houses, kennels, sheds, tarps, clothing and other miscellaneous trash and debris.
- 9. On March 30, 2010, Notices of Violation were mailed to the OWNER and on March 30, 2010 and May 25, 2010 were mailed to INTERESTED PARTIES by certified mail, return receipt requested.
- 10. I am informed and believe and based thereon allege that on April 26, 2010 and June 28, 2010, Officer Heagstedt conducted follow-up inspections and observed that THE PROPERTY remained in violation of RCO 348 (RCC Chapter 17.16) and 541 (RCC Chapter 8.120).
- 11. I conducted a follow up inspection on October 21, 2010 and from the road right of way

observed that the violations remained on THE PROEPRTY.

- A site plan and photographs depicting the condition of THE PROPERTY during the 12. above referenced inspections are attached hereto as Exhibit "D" and are incorporated herein by reference.
- True and correct copies of each Notice issued in this matter and other supporting 13. documentation are attached hereto as Exhibit "E" and incorporated herein by reference.
- Based upon my experience, knowledge and visual observations, it is my determination 14. that the conditions on THE PROPERTY are dangerous to the neighboring property owners and the general public.
- I am informed and believe and based upon said information and belief allege that the 15. OWNER and INTERESTED PARTIES do not have legal authority or permission to store or accumulate the above described materials on THE PROPERTY.
- A Notice of Non-Compliance was recorded in the Office of the County Recorder, County 16. of Riverside, State of California, on July 31, 2009 as Instrument Number 2009-0400301, a true and correct copy of which is attached hereto and incorporated herein by reference as Exhibit "F".
- On November 15, 2010, I conducted a follow-up inspection on THE PROPERTY that 17. revealed the excess outside storage and accumulated rubbish remained on THE PROPERTY in violation of RCO 348 (RCC Chapter 17.16) and 541 (RCC Chapter 8.120).
- On November 10, 2010, the second notice "Notice to Correct County Ordinance 18. Violations and Abate Public Nuisance" providing notification of the Board of Supervisors' hearing scheduled for December 7, 2010, as required by Riverside County Ordinance No. 725, was mailed to OWNER and INTERESTED PARTIES by certified mail, return receipt requested and on November 15, 2010, was posted on THE PROPERTY. True and correct copies of the notice, returned receipt cards, together with the proof of service, and the affidavit of posting of notices are attached hereto as Exhibit "G" and incorporated herein by reference.
- The removal of all outside storage of materials and the removal of accumulated rubbish 19. currently on THE PROPERTY is required to bring THE PROPERTY into compliance with Riverside Given that the parcel is County Ordinance Nos. 348, 541 and the Health and Safety Code.

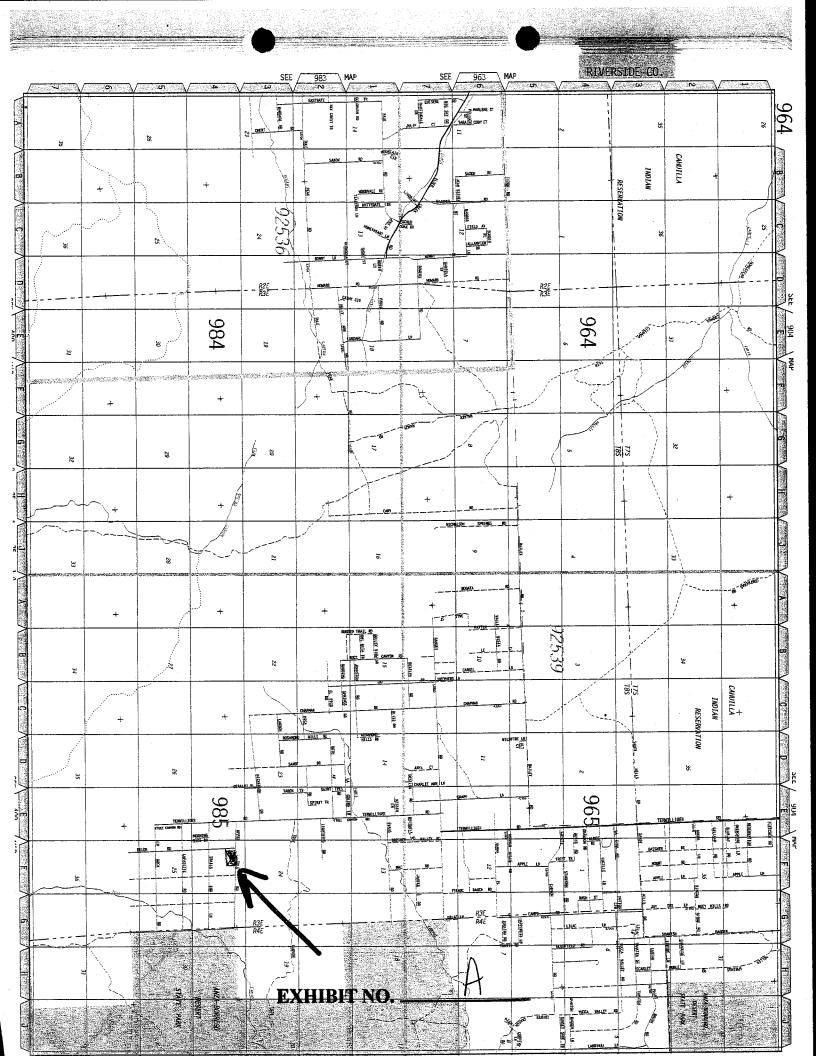
no amount of outside storage is allowed on THE PROPERTY under RCO No. 348. unimproved, Under RCO No. 541, no amount of rubbish is allowed to be accumulated on THE PROPERTY.

- 20. Accordingly, the following findings and conclusions are recommended:
- the outside storage of materials and accumulated rubbish on THE PROPERTY be (a) deemed and declared a public nuisance; and
- (b) the OWNER or whoever have possession or control of THE PROPERTY be required to remove all outside storage of materials and accumulated rubbish on THE PROPERTY in accordance with the provisions of RCO Nos. 348 and 541.
- (c) that if the materials and rubbish are not removed and disposed of in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance Nos. 348 and 541, within ninety (90) days of the date of the Order to Abate Nuisance, the outside storage of materials and accumulated rubbish shall be abated and disposed of by representatives of the Riverside County Code Enforcement Department, a contractor or the Sheriff's Department upon receipt of an owner's consent or a Court Order when necessary under applicable law.
- (d) that reasonable costs of abatement, after notice and opportunity for hearing, shall be imposed as a lien on THE PROPERTY, which may be collected as a special assessment against THE PROPERTY pursuant to Government Code Section 25845 and Riverside County Ordinance Nos. 348 and 725.

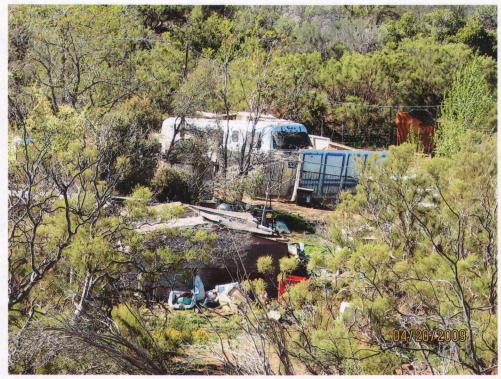

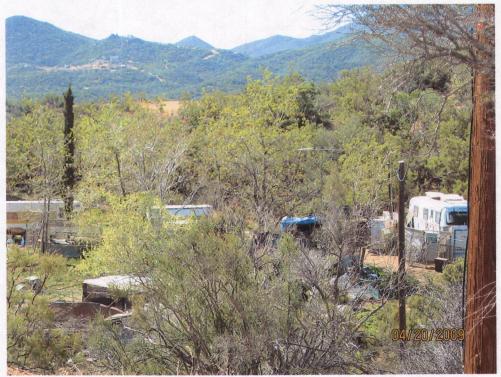

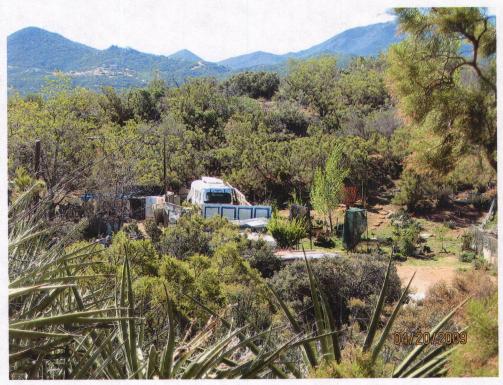

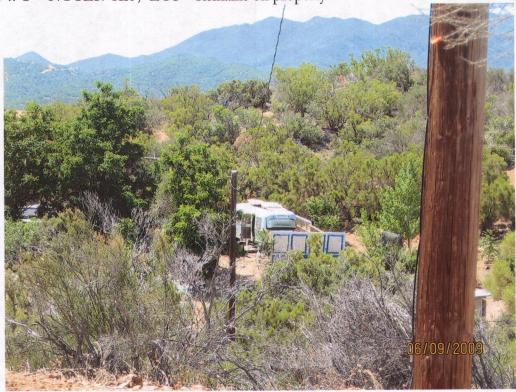

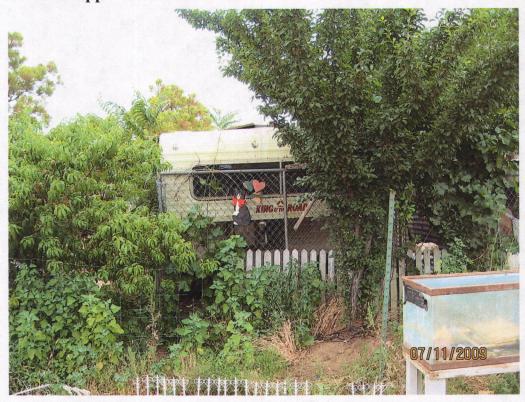

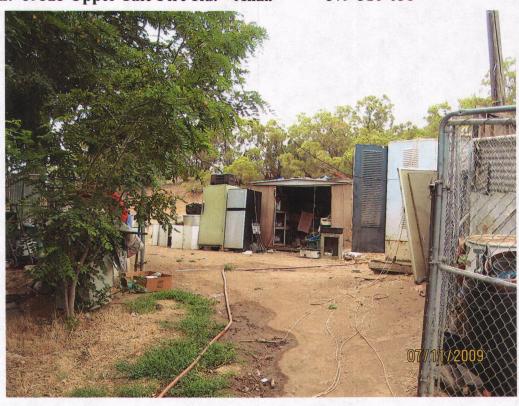

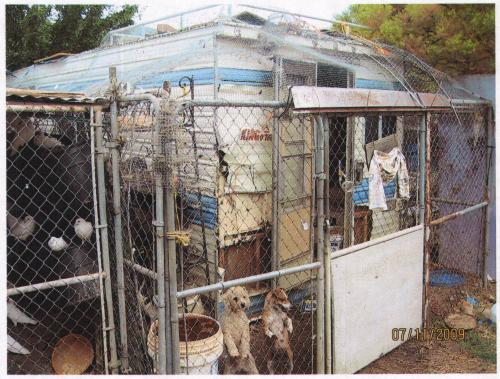


PHOTO # 10 NOTES: SS Trailer and EOS – Still on Property

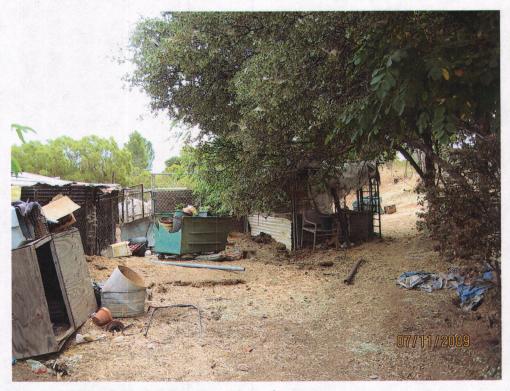

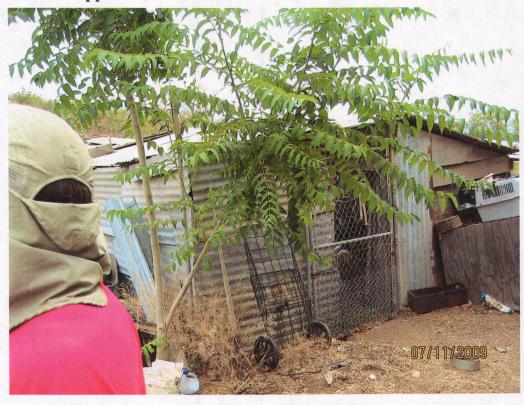


PHOTO # 13 NOTES: EOS – Still on property
