**SUBJECT: Distribution of Highway Right of Way Rental Payments  
Pursuant to Streets and Highways Code 104.10**

**RECOMMENDED MOTION:** That the Board approves the distribution of \$ 548.69 in Highway Rental Payments for the Fiscal Year 2010-11 as detailed in Attachment A.

**BACKGROUND:** Pursuant to Streets and Highways Code 104.10, which reads in part: "The county auditor shall distribute any payment received by the county pursuant to this section, to the county, to each revenue district for which the county assesses and collects real property taxes or assessments, and to every other taxing agency within the county in which the property is situated in the amount as determined by the board of supervisors, except that one-half of the allocation for a rental property shall be allocated to the city in which the rental property is located... The money received by the respective jurisdictions under this section shall be expended only for the purposes authorized by Article XIX of the California Constitution."

Article XIX of the California Constitution restricts the expending of such money to those agencies providing road related services. The department has researched the tax rate areas involved and has found that the attached list represents those agencies capable of expending the money in the prescribed manner.
