SECOND AMENDMENT TO CONTRACT FOR ANIMAL SHELTER SERVICES

COUNTY OF RIVERSIDE

THIS SECOND AMENDMENT TO CONTRACT FOR ANIMAL SHELTER SERVICES ("Second Amendment"), is made and entered into this December 14, day-of, 2010, by and between the CITY OF RIVERSIDE, a charter city and municipal corporation, hereinafter referred to as "City," and the COUNTY OF RIVERSIDE, a political subdivision of the State of California, hereinafter referred to as "County," with respect to the following facts:

RECITALS:

WHEREAS, on July 1, 2007, City and County entered into that certain Agreement for Animal Shelter Services ("Agreement"), wherein County agreed to provide animal shelter services during the period of July 1, 2007 through June 30, 2012; and

WHEREAS, on April 22, 2010, the City and County amended the Agreement; and

WHEREAS, City and County desire to further amend the Agreement to revise the Scope of Services to include animal web-licensing services effective December 15, 2010;

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and County agree as follows:

1. Section 7(k), "Term" of the Agreement is hereby amended in its entirety as follows:

"Payments of Fees and Charges by the Public. County shall receive payments for impoundments, boarding, adoption, licensing or other fees and charges levied at the Shelter. When tendered by check, money order or other non-cash remittance, such payment shall be made payable to "City of Riverside". County shall deposit all such fees and charges collected in a City bank account as designated by City by no later than the close of the next business day. City will provide a deposit endorsement stamp issued by City's bank of choice that will be used to stamp the back of each check for deposit into City's account. City shall be responsible for clearance and payment of all checks or other non-cash remittances deposited into City's account. Collection charges on City residents shall be paid for solely by City. City shall pay for the implementation of a non-

cash system for resident payments to the shelter, such as the use of credit card/debit card terminal systems and web-licensing. County shall deposit all web-licensing fees into County bank and deduct license fees collected on behalf of City residents from City monthly billings each calendar month. County shall retain web-license processing fee of \$1.50 collected for each transaction to off-set cost per transaction. County shall provide City a monthly accounting of all deposits for each calendar month in such detail as reasonably required by City by no later than the twenty-fifth (25th) day of the following month."

2. All terms and conditions of the Agreement not inconsistent with this Second Amendment, shall remain in full force and effect and are incorporated herein by this reference as if set forth in full.
