SUBJECT: State Legislative Advocacy Services

RECOMMENDED MOTION: That the Board of Supervisors approve and authorize the Chairman to sign a one year extension of the agreement with Michael Y. Corbett to provide state legislative advocacy services.

BACKGROUND: Since 2003 the County has used a variety of contractors to provide a bipartisan state lobbying team, with Michael Corbett serving as the Sacramento-based legislative coordinator. The team includes California Strategies and Neilsen, Merksamer, Parrinello, Mueller and Naylor has worked with Board members and staff to effectively promote the County's positions and has established productive relationships with legislators and administrative officials. The attached agreement will continue all current services through Mr. Corbett. The agreement was prepared with a ten percent (10%) reduction to the compensation initially offered.

**SECOND AGREEMENT RENEWAL
BETWEEN COUNTY OF RIVERSIDE
AND MICHAEL Y. CORBETT**

The Agreement between the County of Riverside and Michael Y. Corbett (Consultant) approved by the Board of Supervisors on December 20, 2005 Agenda item 3.8 and extended for the first time on December 1, 2009 Agenda item 3.10 is hereby renewed effective January 1, 2011 and shall continue in effect through December 31, 2011.

The total compensation will be \$122,400 a reduction of ten percent (10%) from the original contract. The monthly bill shall not exceed \$10,200.

All other terms and conditions of the Agreement remain the same.
