BACKGROUND: On June 4-6, 2010, the Temecula Valley Balloon & Wine Association (Association) held its annual event at Lake Skinner Recreation Area in Winchester, California. The event generated \$48,001 in revenue to the Regional Park and Open-Space District (District) from gate admissions, parking, and camping. There was excellent cooperation among the community, Association, Riverside County Fire Department, Riverside County Sheriff's Department, US Immigration and Naturalization Service, City of Temecula, Metropolitan Water District, California Highway Patrol, and District.
