Dear Supervisor Stone:

Yesterday afternoon I had the opportunity to watch your interview on FOX NEWS regarding the Secession of Thirteen Counties from the state of California in order to establish the new state of South California. Please accept my heartfelt congratulations on taking the leadership position in this noble and worthy cause.

I am a fourth generation California through the immigration of a paternal ancestor to Alta California which at the time was a Territory and Department of the Republic of Mexico. Presently, I am a resident of the Unincorporated Community of Castaic, California which is located within the Santa Clarita Valley in the Northwest Section of Los Angeles County.

For the past two decades, California has become increasingly dysfunctional and progressively insolvent with every passing fiscal year. By-and-large at the State Government level, there is no desire either at the Executive and Legislative Branches to reform the situation and prevent the financial collapse of the state of California. I wholly agree with you that there are currently very entrenched and politically powerful interests and organizations whose vested financial stakes dictate their continuing and unrelenting opposition to any attempt to change the status quo in our State Government. Furthermore implicit in your Secession Movement, is the recognition that to date, efforts to significantly change the way policies are promulgated within the State Government, have irrevocably failed.
