

2. Direct the County Clerk to file the executed Notice of Completion


BACKGROUND: On July 12, 2010, the Board awarded Layne Christensen Company the contract for the Completion of Corehole Drilling at the Closed Anza Sanitary Landfill. On November 8, 2010, the Completion of Corehole Drilling at the Closed Anza Sanitary Landfill was satisfactorily completed. The final cost for the Completion of Corehole Drilling at the Closed Anza Sanitary Landfill was \$20,060.00, which is less than the total authorized contract amount of \$31,000.00.



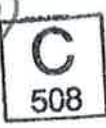
