Pursuant to the contract, three work orders were issued for the installation of wall coverings and painting at the Riverside Federal Bankruptcy Court in the combined amount of \$332,426. The project has been inspected and found to comply with all contract requirements. This Board action will release the balance of the contract retention funds of \$33,243 to MTM Construction, Inc.

All costs associated with this agreement will be fully funded by the Federal Bankruptcy Court, thus no further net county cost will be incurred as a result of this agreement.
