4. Authorize the release of the remaining 5% retention on the project and further authorize the Agency to process final payment subject to Agency staff working with the Surety for J.D. Diffenbaugh to finalize and close out the project, including clearing up any and all remaining stop notices and/or performance issues.

BACKGROUND:

On September 30, 2008, the Board of Directors approved the construction contract between J.D. Diffenbaugh and the Redevelopment Agency (RDA) for the County of Riverside for the construction of the Northwest Animal Shelter Project. J.D. Diffenbaugh sent RDA a letter of default stating they would not be able to carry out its contractual obligations. The Surety for J.D. Diffenbaugh, Safeco Insurance Company of America has engaged a consulting firm to close out the project, including dealing with stop notices filed against the project and to finalize all work. At the time the letter was received, the project was approximately 99% complete. All remaining work has been addressed by Surety and their agents. Only minor items of cost and work remain to be resolved. RDA and Surety have agreed that the facility is complete for warranty purposes as of June 16, 2011. As stop notice releases or release bonds are received, the remaining balance of the contract payment will be sent to the Surety pursuant to Surety's agreement with J.D. Diffenbaugh and the direction of the letter of default.

RDA recommends that the Board of Directors receive and file the Voluntary Notice of Default letter from J.D. Diffenbaugh, approve and authorize the Chairman to sign the Notice of Cessation, authorize the Clerk of the Board to record the Notice of Cessation, and authorize the release of the remaining 5% retention on the project and further authorize RDA to process final payment subject to RDA staff working with the Surety for J.D. Diffenbaugh to finalize and close out the project, including clearing up any and all remaining stop notices and/or performance issues.

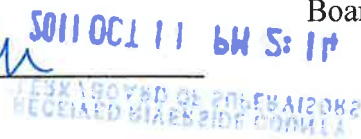
