Jackie Lee McDonald began modeling at age eleven and continued through high school and college, leading to an early television career as Seattle's first female weather reporter. A graduate from the University of Washington with a degree in home economics and fashion design, Jackie Lee McDonald, then Miss Washington, met Jim in the 1950s, married in 1956 and settled in Baltimore and British Columbia, during her husband's service in the United States Air Force.

In 2002, Jackie Lee Houston made a mark as one of only two women in the United States to own a television station, CBS affiliate KPSP Local-2. A philanthropist with few equals, Jackie Lee Houston was instrumental to the continued success of the Palm Springs International Film Festival, one of the Coachella Valley's signature events, raised millions of dollars over the years to more than fifty charities and nonprofits and served as a gracious hostess to numerous fundraising events for charities on the grounds of the Houston Estate.

Jackie Lee Houston is survived by her husband, Jim, three children and grandchildren. Her memory, warmth and generosity will live forever in the hearts of everyone who knew her. She will be dearly missed.

Born in Harlem in 1909, Dolores DeFina knew at an early age that she wanted to be a singer. In 1933, she performed at the Vogue Club in New York where she met and quickly caught the attention of a young comedian visiting the club, Bob Hope, marrying months later, in 1934.

The Hopes established a home in the desert in the 1940s and were among the most generous philanthropists. Dolores Hope dedicated countless hours and millions of dollars to numerous local charities.

The Hopes donated 80 acres of land in Rancho Mirage to establish Eisenhower Medical Center. Dolores Hope served as founding president and served more than three decades on the hospital's board. Her leadership helped establish the hospital's legacy as an institution of high quality health care and helped ensure that \$35 million raised from the Bob Hope Classic would benefit Eisenhower Medical Center's mission.

Dolores Hope also joined her husband in making eight overseas trips to bring laughter and cheer to servicemembers abroad, and in 1990, sang "White Christmas" to troops in Saudi Arabia. In recognition of her talent, patriotism, community service and generosity, Dolores Hope received more than 40 major awards internationally.

Preceded in death by her husband in 2003, Dolores Hope is survived by three children, Linda, Kelly and Nora, three grandchildren and a great-grandson.

Her memory and passionate spirit will live forever in the hearts of everyone who knew and loved her. She will be dearly missed. The Board of Supervisors commemorates her service to the County of Riverside.
