BACKGROUND:

The Mizell Senior Center is in need of replacing a van used to deliver meals to seniors in Cathedral City. They would like to purchase a hybrid van that will be more dependable and cost efficient.

The Golden Rainbow Senior Center is requesting a financial contribution to help refurbish their new center. Golden Rainbow is expanding community-based programs along with responding to the increased need for counseling services that necessitates the move to a bigger facility.

Jewish Family Services of the Desert serves more than 1,700 households with services for "at risk" youth, vulnerable seniors, struggling families, and those in need of mental health and substance abuse counseling.
