SUBJECT: Budget Adjustment to the Human Resources Delta Dental Fund.

RECOMMENDED MOTION: That the Board of Supervisors approve and direct the Auditor-Controller to increase appropriations and increase revenue in the Human Resources Delta Dental Fund by \$2,600,000 as outlined in Attachment "A".

BACKGROUND: Delta Dental was approved by your Board as the replacement for the United Concordia and Freedom dental plans for 2011. We have established an HMO and a PPO plan with this provider. The PPO plan is self funded and operates as an Internal Service Fund with budgetary authority. The HMO is an insured plan and a premium pass through agency fund. The plan year starts in January 2011, so we must establish a six month budget and appropriation authority to operate the plan for FY 10-11. We have estimated the FY 10/11 six month revenue and expenditure plan based on the recent open enrollment data. There is no direct cost to the County associated with this recommended action.
