Item 3.90 Pull for Discussion

I am proposing an alternative Board meeting schedule for 2011. In 2010, the number of Board meetings was reduced by 16 to allow for conference attendance, vacation time and to better reflect the lack of County agenda items in this bad economy. This reduction in meetings resulted in a cost savings of per meeting of \$3,400 for staff time, \$400 for use of Pictron and \$100 for internet usage for a savings of \$62,400. This does NOT include savings realized from reduced supplies, utilities, mileage paid, lunch or any other expenses for preparation of agendas and attendance at meetings.

I would propose that in 2011 we again allow for conference attendance and vacation by reducing meetings in March from 5 to 4 (NACO); April from 4 to 3 (Spring Break); July meetings from 3 to 2 (NACO), holding only 1 meeting in August (Vacation) and reducing November meetings from 5 to 4 (CSAC) for a total reduction of 8 meetings.

Traditionally, the Board has been dark the month of August and I don't support going 6 weeks without a Board meeting. I propose going dark 8/2 and 8/9, meeting on 8/16 and going dark 8/23 and 8/30. This would reduce the number of Board meetings for the entire year by 7 resulting in a minimum cost savings of \$33,200 and would allow Board participation at all conferences and vacation time for the Board and County staff.

I believe the reduced amount of items before the Board, the cost savings, and the advance notice for staff allows for advanced planning and is preferable to cancelling meetings due to a lack of quorum or agenda items.
