SUBJECT: FY 2011-2012 Service Rates for Riverside County Information Technology

RECOMMENDED MOTION: Move that the Board of Supervisors:

1. Approve the attached Riverside County Information Technology (RCIT) service rates for FY 2011-2012;
2. Approve and direct the Auditor-Controller to assign unrestricted net assets for future operations as reflected in Attachment A; and,
3. Authorize the RCIT department head to enter into service agreements with non-county agencies for information technology services up to \$10,000.

BACKGROUND: As an internal service fund (ISF), RCIT develops a budget based on the current business environment, which this year is marked by the County's fiscal environment and changes in the demand for services. *(Continued on Page 2)*

BACKGROUND: (Continued)

A budgetary fiscal contraction, decreases in service demand, and the SEIU IT salary settlement agreement were material factors with the greatest impact on the development of the FY11/12 budget. Cost savings continue to be achieved in specific areas as a result of the staff's work with service providers to negotiate lower service rates, maximize contract savings and collaborate on volume purchases. Staffing costs were also reduced through early retirements. As a result, RCIT services to departments represent an overall 2.6% decrease in IT costs to customers.

To further reduce operating costs, with associated reductions in rates, RCIT removed funding for emergency site and facility repairs for the radio and microwave facilities. Therefore, in lieu of rebates to user departments, RCIT is seeking a \$500,000 assignment of unrestricted assets as a reserve to address unforeseen emergency repairs to public safety radio and microwave operations, without burdening rates. There are sufficient unrestricted net assets in the RCIT fund to cover this request.

Attachment A identifies previously approved Board assignments along with new assignments. Other new assignments requested, in lieu of rebates to user departments, include the emergency grounding work at Alessandro for the 911 Dispatch Center and PSEC and the SEIU Back Pay Settlement that is estimated at \$800,000 to \$1,000,000. If additional budget savings or adjustments are made to fund balances, RCIT will return to the Executive Office and Board to further assign unrestricted net assets and/or rebates.

RCIT has been requested to provide IT services to outside agencies such as the Bureau of Land Management, California Highway Patrol, Riverside Community Colleges, cities and other agencies. We are requesting that the Board delegate authority to the RCIT department head to enter into service agreements with outside agencies using current Board approved rates up to a per agreement value of \$10,000. Any agreements greater than \$10,000 will be forwarded to the Board for approval.

The assignment of unrestricted net assets is for conversion costs (phases 4-6) with the expectation of lease payments starting in 2011/12.
SEIU Back Pay Settlement	1,000,000	RCIT was recently informed of a settlement agreement with SEIU that will result in back pay for approximately 50 employees. Initial estimates from HR range from \$800,000 to \$1,000,000 in back pay. HR has advised it will take 3-9 months to complete the calculations. We recommend using available unrestricted net assets to address this liability.
