BACKGROUND: Government Code § 25845, Riverside County Ordinance Nos. 520 (RCC Title 10), 457 (RCC Title 15) and 725 (RCC Title 1.16) authorize for the recovery of abatement costs in public nuisance cases, the recordation of a notice of abatement lien and inclusion of abatement costs on the tax roll as a special assessment upon approval of the Board of Supervisors.

The Riverside County Code Enforcement Department issued a Notice of Intention to Abate and Remove on Sept. 25, 2009 with regard to CV09-06547 and April 6, 2010 with regard to CV09-06548. 
