The Department of Animal Services (DAS) has been providing animal field services for the City of Palm Desert (CITY) since 2003 in order to safeguard the CITY's domestic and wild animals, promote the humane treatment of animals, and enforce the CITY's Ordinances and State laws relating to animal control. The CITY's animals are housed at the County run shelter at the Coachella Valley Animal Campus.

The period of performance of July 1, 2008 through June 30, 2009 was not properly amended due to a misunderstanding in the original agreement. Therefore, notification is given to the Board of Supervisors at this time for services rendered.

**TO THE MEMORANDUM OF UNDERSTANDING
BETWEEN
RIVERSIDE COUNTY DEPARTMENT OF ANIMAL SERVICES
AND CITY OF PALM DESERT**

(Field Services to City)

That certain Memorandum of Understanding (MOU) between the County of Riverside through its Community Health Agency, Department of Animal Services (COUNTY) and City of Palm Desert (CITY), approved on January 15, 2008, amended for the first time effective date July 1, 2009, amended for the second time on August 27, 2009 by the Purchasing Agent, is hereby amended for the third time, effective July 1, 2010.

- Ratify the performance period for services rendered during July 1, 2008 through June 30, 2009 budgeted in the amount of one hundred four thousand, four hundred seventy dollars (\$104,470).
- Amend all references to the period of performance from July 1, 2009 through June 30, 2010 to July 1, 2010 through June 30, 2011.
- To decrease the estimated amount of compensation for Fiscal Year 2010/2011 from one hundred nineteen thousand, seventy seven dollars (\$119,077) to one hundred eighteen thousand, eight hundred ninety six dollars (\$118,896), including all expenses.
- To delete "Exhibit C – Fiscal Year Budget" in its entirety and replace it with "Exhibit C – Fiscal Year Budget", attached hereto;
- All other terms and conditions of this MOU are to remain unchanged.
