

BACKGROUND:

By Minute Order dated December 7, 2010 (agenda item 3.35), the Board authorized the Clerk of the Board to advertise for the resurfacing and reconstruction of portions of Varner Road and Rio Del Sol Road in the Thousand Palms community of the Coachella Valley. Additionally, the specifications were approved by the Board within this agenda item.

During the advertisement period, one addendum was issued to all registered plan holders as a supplement to the specifications and special provisions. Bidders are required to acknowledge and to take into account all issued addenda on their Contractor's Proposal to be considered for award. The addendum was issued to clarify and modify the approved contract documents. The addendum is attached as Addendum No. 1

Bids for the project were opened in the office of the Director of Transportation at 2:00 PM, Wednesday, December 29, 2010. Four bids were received. The basis for the selection of a contractor is the lowest responsive and responsible bid. The lowest responsible bid was submitted by Match Corporation in the amount of \$1,552,000 which is \$272,000 (15%) below the Engineer's Estimate.

Roadway resurfacing is a preventive measure and reconstruction is needed due to deteriorated pavement conditions. The road improvements will consist of grinding the existing pavement in place, removing or cold plane pavement, re-grading the surface, and placing of new AC pavement and PCC pavement.

The project will be completed within the existing budget shown on Attachment "A".

The contractor is qualified, has executed the contract, and has provided bonds and insurance documents which meet the contract requirements.

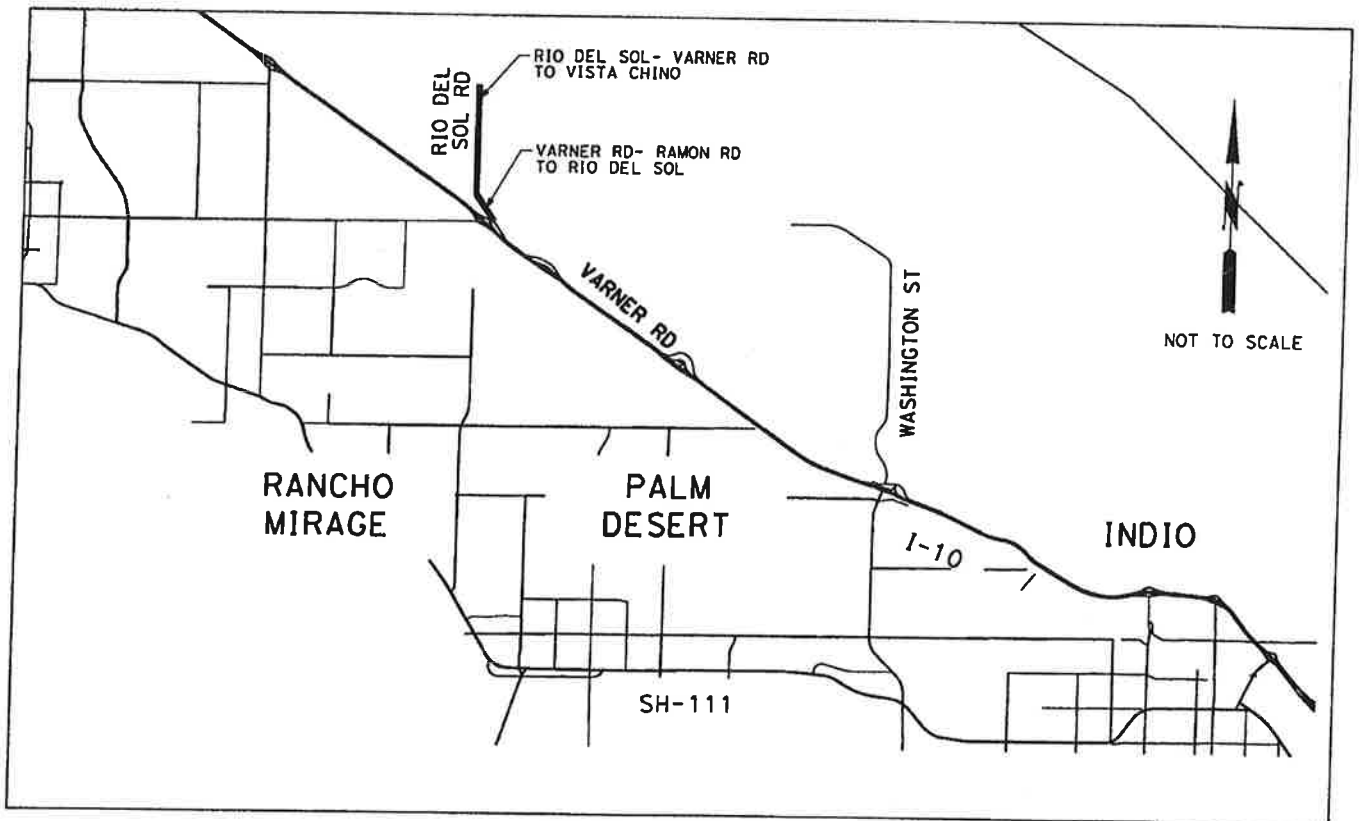
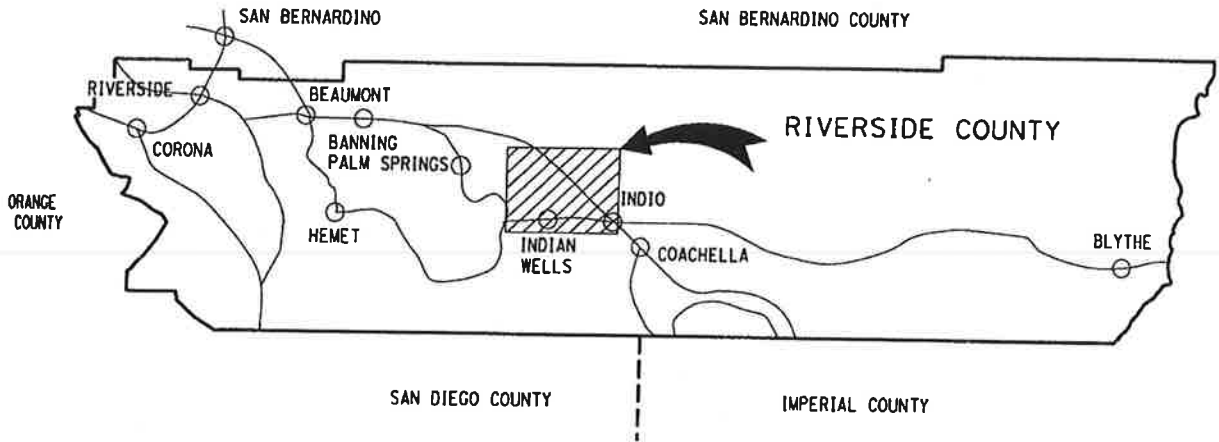

This Addendum is issued pursuant to the instructions to Bidders, Item No. 8, of the Contract Document for the referenced project. This Addendum is issued as a supplement to the plans, specifications and special provisions for the referenced project. Any revisions to the plans and specifications shall become a part of the Contract Documents, and each bidder shall acknowledge receipt thereof on the Contractor's Proposal. Bidders are directed to sign this addendum as acknowledged, and attach the signed addendum to the contractor's submitted proposal.

MODIFICATIONS / CLARIFICATIONS TO SPECIAL PROVISIONS

Item 1: Revised Proposal. Refer to "Proposal" page B3. Proposal (page B3) is deleted and replaced with revised "Proposal" attached herewith as **Attachment "A"**. The following additional revisions have been made to the Proposal bid schedules:

a. The following bid items have been added:

- Item 26, "CONSTRUCTION PROJECT FUNDING IDENTIFICATION SIGNS"
- Item 27, "OBTAIN ENCROACHMENT PERMIT"

Item 2: **Construction Project Funding Identification Sign.** Refer to section "CONSTRUCTION PROJECT FUNDING IDENTIFICATION SIGN" on pages 56 through 57. The entire provision is deleted and replaced with the following:

"The Contractor shall furnish and install **four (4)** Construction Project Funding Identification Signs (4' X 8'); the signs shall be installed at locations to be determined by the Engineer, within or near the project limits, in accordance with the relevant requirements of Section 56-2 of the Standard Specifications and the appropriate details of Standard Plans RS1 through RS4 for two post installation of signs, and as directed by the Engineer.

A reference exhibit displaying the text and colors of the sign will be provided to the Contractor prior to construction. The Contractor shall submit a copy of the final sign design for approval by the resident Engineer prior to fabrication.

The Contractor shall submit to the Engineer the final sign design in the form of an editable picture file in .eps format – Encapsulated PostScript file.

At the completion of the project, the signs will become property of the County. When directed by the Engineer, the Contractor shall remove all hardware from the signs. Posts and hardware shall become the property of the Contractor. The Contractor shall deliver and off-load the signs to the address listed below or as directed by the Engineer:

Method of Payment

The contract price paid **per each** for Construction Project Funding Identification Sign shall include full compensation for furnishing all labor, materials, tools, equipment, incidentals and for doing all the work including sign installation, transportation, maintenance, removal, delivery, excavation and backfill as specified in the Standard Specification and these Special Provisions and no additional compensation will be allowed therefor."

Item 3: The following drawing is included as **Attachment "B"**, which is made a part hereof:

- CONSTRUCTION PROJECT FUNDING IDENTIFICATION SIGN, Exhibit

Item 4: **Order of Work.** Refer to section entitled "ORDER OF WORK" page 50. The following paragraph is added after the last paragraph on page 50:

"Attention is directed to "Cooperation" of these Special Provisions regarding additional work. A commercial development has been approved on Rio del Sol from approximately Sta 35+35 to Sta 42+00. Construction of the developments street improvements are anticipated to start prior to the Rio del Sol reconstruction project. To avoid delays, if the concrete curb, gutters have been completed by the development prior to the asphalt grinding on Rio del Sol, the Contractor shall excavate, scarify, compact to 95%, place and compact 0.50' of AB, CL-2 and place 0.58' HMA to match the existing gutter lip. If the concrete curb and gutters are not complete and accepted by an Inspector with the County of Riverside, this additional paving shall not be provided. The additional Roadway Excavation, Aggregate Base and Hot Mix Asphalt shall be paid at the unit price indicated on the Proposal."

Item 5: **Water Pollution Control (Colorado River Basin Region- Risk Level 1).** Refer to section entitled "WATER POLLUTION CONTROL (COLORADO RIVER BASIN REGION- RISK LEVEL 1)" pages 58 through 65. Delete the third paragraph on page 61 and replace with the following:

"Within **ten (10)** working days after the award of the contract, the Contractor shall submit two (2) copies of the SWPPP/MP to the Engineer for review and approval. The Contractor shall allow **five (5)** working days for the Engineer to review the SWPPP/MP. If revisions are required as determined by the Engineer, the Contractor shall revise and resubmit the SWPPP/MP within three (3) working days of receipt of the Engineer's comments and shall allow **five (5)** working days for the Engineer to review the revisions. The Contractor shall submit four (4) copies of the approved SWPPP/MP to the Engineer prior to notice to proceed. The Contractor must have an approved SWPPP/MP prior to the notice to proceed. The Engineer may provide a letter of conditional approval of the Contractor's SWPPP/MP while minor revisions are made and may allow the Contractor to begin only those certain construction activities identified in the letter of conditional approval. In no case will the conditional approval extend beyond twenty-one (21) calendar days. The Engineer may suspend construction operations until the Contractor submits a revised SWPPP/MP that is reviewed and approved by the Engineer."

Item 6: **Traffic Control System.** Refer to section entitled "TRAFFIC CONTROL SYSTEM/ PUBLIC CONVENIENCE/ PUBLIC SAFETY" pages 51 through 52. The following paragraph is added after the first paragraph on page 51.

"For Varner Road, the contractor must also submit the plans to Caltrans for review and approval. The contractor shall obtain a duplicate State of California Department of Transportation Encroachment Permit, as described in OBTAIN ENCROACHMENT PERMIT.

Item 7: Obtain Encroachment Permit. The following Special Provisions are added hereby:

"It shall be the responsibility of the Contractor to obtain a duplicate State of California Department of Transportation (Caltrans) Encroachment Permit, and pay all fees required for the work done within State Right-Of-Way prior to commencing any work. All work shall comply with the Caltrans issued permit.

The Contractor shall submit a request for payments of all fees paid by the Contractor upon completion of all work within State Right-Of-Way. The request shall include copies of all permits and receipts and refund payment documents issued by Caltrans.

Payment:

Full compensation for the actual cost of Encroachment Permit fees, as paid by the Contractor to Caltrans shall be included in the price paid on force account basis for Obtain Encroachment Permit in accordance with Section 9-1.03 of the Standard Specifications and these Special Provisions, up to the fixed bid price. No markups will be allowed. All incidental costs incurred by the Contractor shall be included in the various items of work, and no compensation will be allowed therefor".

Item 8: Insurance. The following Special Provisions are added hereby:

"In addition to the requirements of Section 18, "Insurance – Hold Harmless" of the contract documents, the Contractor's Certificate of Insurance and endorsements for the project shall name the following listed entities as additional insureds under the Contractor's general liability, excess liability and auto liability insurance policies and each listed entity shall be on the Waiver of Subrogation for the Contractor's Workers Compensation policy.

1. "State of California, Department of Transportation, its officers, directors, agents and employees".

Each of the above listed entities shall also be held harmless, in accordance with the requirements of subsection IV, "Hold Harmless of Section 18, "Insurance – Hold Harmless" of the contract documents.

Full compensation for compliance with the requirements of this Section shall be considered as included in the various items of work and no additional compensation will be allowed therefore."

Item 9: **36" High Pressure Gas Pipeline.** The Contractor's attention is directed to the existence of a Southern California Gas Company owned 36" high pressure gas pipeline, which crosses Rio Del Sol Road at approximately Station 76+00.

Prior to performing any work within 50 feet of the gas pipeline, the Contractor shall provide at least 48 hours notice to the Gas Company, so that the Gas Company can observe the Contractor's operations if they so choose.

Item 10: **Cooperation.** Refer to section entitled "COOPERATION" page 54. The following two paragraphs are added after the second paragraph:

"CVWD will adjust all facilities that are owned by the Coachella Valley Water District, and which require adjustment to grade. Please contact Tyler Hull at (760) 398-2651 at least 48 hours in advance of any work affecting CVWD surface facilities.

A commercial development has been approved on Rio del Sol from approximately Sta 35+35 to Sta 42+00. Construction of the developments street improvements are anticipated to start prior to the Rio del Sol reconstruction project. To avoid delays, if the concrete curb, gutters have been completed by the development prior to the asphalt grinding on Rio del Sol, the Contractor shall excavate, scarify, compact to 95%, place and compact 0.50' of AB, CL-2 and place 0.58' HMA to match the existing gutter lip. If the concrete curb and gutters are not complete and accepted by an Inspector with the County of Riverside, this additional paving shall not be provided. The additional Roadway Excavation, Aggregate Base and Hot Mix Asphalt shall be paid at the unit price indicated on the Proposal."

- Delete construction note 21 and replace with "Pulverize existing pavement to a depth of 0.50', compact to 95%, regrade to match existing cross slope, and overlay with 0.45 HMA."

If revisions are required as determined by the Engineer, the Contractor shall revise and resubmit the SWPPP/MP within **three (3)** working days of receipt of the Engineer's comments and shall allow **five (5)** working days for the Engineer to review the revisions. The Contractor shall submit **four (4)** copies of the approved SWPPP/MP to the Engineer prior to notice to proceed. The Contractor must have an approved SWPPP/MP prior to the notice to proceed. The Engineer may provide a letter of conditional approval of the Contractor's SWPPP/MP while minor revisions are made and may allow the Contractor to begin only those certain construction activities identified in the letter of conditional approval. In no case will the conditional approval extend beyond **twenty-one (21)** calendar days. The Engineer may suspend construction operations until the Contractor submits a revised SWPPP/MP that is reviewed and approved by the Engineer."

Item 6: **Traffic Control System.** Refer to section entitled "TRAFFIC CONTROL SYSTEM/ PUBLIC CONVENIENCE/ PUBLIC SAFETY" pages 51 through 52. The following paragraph is added after the first paragraph on page 51.

"In addition to the requirements of Section 18, "Insurance – Hold Harmless" of the contract documents, the Contractor's Certificate of Insurance and endorsements for the project shall name the following listed entities as additional insureds under the Contractor's general liability, excess liability and auto liability insurance policies and each listed entity shall be on the Waiver of Subrogation for the Contractor's Workers Compensation policy.

1. "State of California, Department of Transportation, its officers, directors, agents and employees".

Each of the above listed entities shall also be held harmless, in accordance with the requirements of subsection IV, "Hold Harmless of Section 18, "Insurance – Hold Harmless" of the contract documents.

Full compensation for compliance with the requirements of this Section shall be considered as included in the various items of work and no additional compensation will be allowed therefore."

To avoid delays, if the concrete curb, gutters have been completed by the development prior to the asphalt grinding on Rio del Sol, the Contractor shall excavate, scarify, compact to 95%, place and compact 0.50' of AB, CL-2 and place 0.58' HMA to match the existing gutter lip. If the concrete curb and gutters are not complete and accepted by an Inspector with the County of Riverside, this additional paving shall not be provided. The additional Roadway Excavation, Aggregate Base and Hot Mix Asphalt shall be paid at the unit price indicated on the Proposal."
