BACKGROUND:

By Minute Order dated December 7, 2010 (agenda item 3.37), the Board authorized the Clerk of the Board to advertise for the resurfacing of San Timoteo Canyon Road and Live Oak Canyon Road in the San Timoteo Canyon area of Riverside County. Additionally, the specifications were approved by the Board within this agenda item.

During the advertisement period, one addendum was issued to all registered plan holders as a supplement to the specifications and special provisions. Bidders are required to acknowledge and to take into account all issued addenda on their Contractor's Proposal to be considered for award. The addendum was issued to clarify and modify the approved contract documents. The addendum is attached as Addendum No. 1.

Bids for the project were opened in the office of the Director of Transportation at 2:00 PM, Wednesday, December 29, 2010. Four bids were received. The basis for the selection of a contractor is the lowest responsive and responsible bid for all schedules of work. The lowest responsible bid was submitted by Matich Corporation in the amount of \$1,035,000 which is \$398,502 (28%) below the Engineer's Estimate.

Roadway resurfacing is a preventive measure and reconstruction is needed due to deteriorated pavement conditions. The road improvements will consist of grinding the existing pavement in place, removing or cold plane pavement, re-grading the surface, placing of new AC pavement, and other improvements as needed. Additional improvements include new pavement striping and raised pavement markers.

The project will be completed within the existing budget shown on Attachment "A".

The contractor is qualified and has executed the contract. The contractor has also provided performance bond, payment bond and insurance documents.

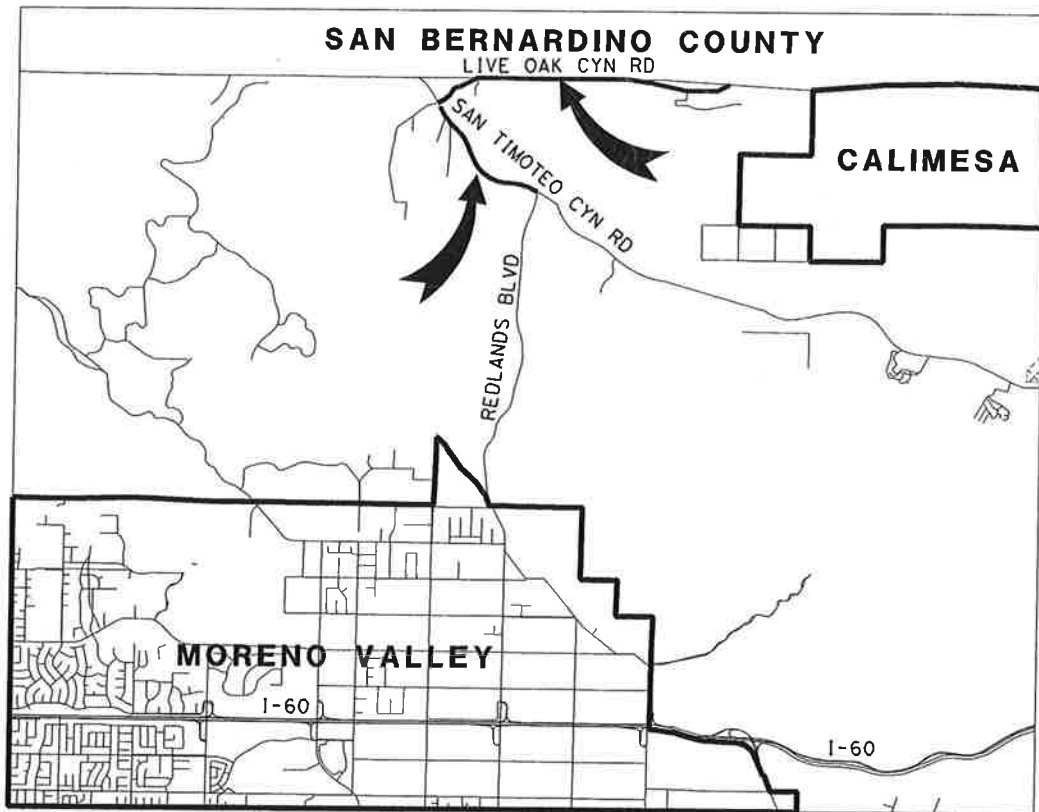
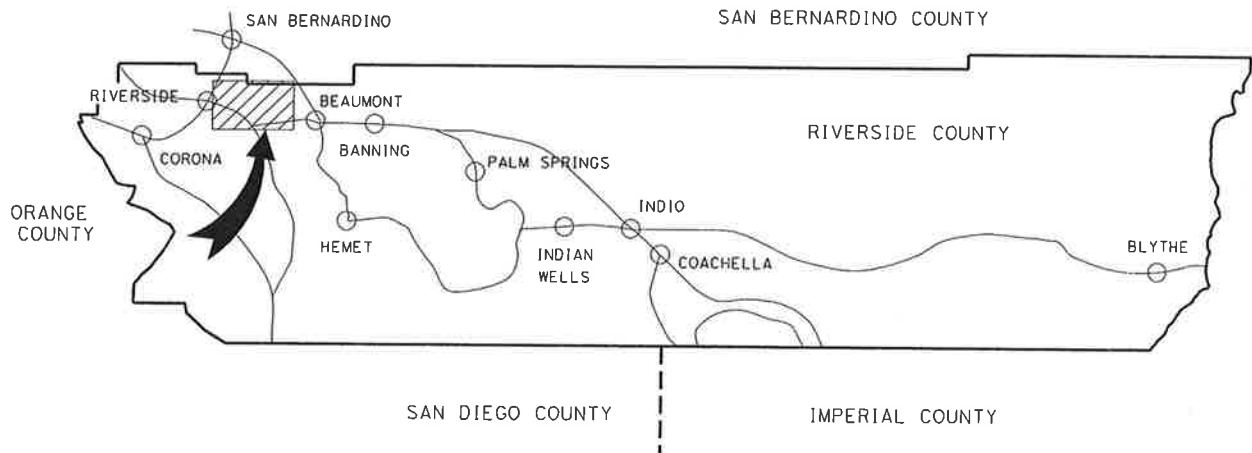

Bidders are directed to sign this addendum as acknowledged, and attach the signed addendum to the contractor's submitted proposal.

MODIFICATIONS / CLARIFICATIONS TO SPECIAL PROVISIONS

Item 1: Revised Proposal.

Refer to "Proposal" page B3. This page is deleted and replaced with revised "Proposal" attached herewith as **Attachment "A"**. The following revisions have been made to the Proposal:

- a. "Estimated Quantities" are changed for the following bid items:
- Item 9, "ROADWAY EXCAVATION"
 - Item 10, "SHOULDER BACKING"
 - Item 12, "CLASS 2 AGGREGATE BASE"
 - Item 13, "ASPHALT CONCRETE OVERSIDE DRAIN (CRS 306)"
 - Item 15, "HOT MIX ASPHALT"

- b. The following bid items have been added:
- Item 22, "CONSTRUCTION PROJECT FUNDING IDENTIFICATION SIGNS"
 - Item 23, "PROTECTION AND REPAIR OF EXISTING IRRIGATION PIPELINE"

Item 2: Liquidated Damages

Refer to section entitled "Liquidated Damages" on page 49. Third and fourth paragraph of this section has been deleted and replaced with the following:

The Contractor shall have 14 calendar days to complete all pavement related work on San Timoteo Canyon Road with additional liquidated damages of \$10,000 per day.

The Contractor shall have 21 calendar days to complete all pavement related work on Live Oak Canyon Road with additional liquidated damages of \$5,000 per day.

Item 3: Order of Work

Refer to section entitled "Order of Work" on page 50. The following additional Special Provisions are added and made part hereof:

"Attention is directed to "Grinding Asphalt concrete in Place" and "Roadway Excavation" of these Special Provisions regarding work procedure. At no time will traffic be allowed on pulverized material, base or subgrade. For San Timoteo Canyon Road, each working night, the Contractor will pulverize, grade, compact and place 0.18' HMA leveling course. For Live Oak Canyon Road, each working day, the Contractor will excavate compact, place and compact base material and place 0.25' leveling course. The final 0.25' lift of HMA shall be placed as the final operation."

Item 4: Construction Project Funding Identification Signs.

Refer to section entitled "Construction Project Funding Identification Signs" on page 54. This entire Special Provision has been deleted and replaced with the following:

"The Contractor shall furnish and install Construction Project Funding Identification Signs (4' X 8'); the signs shall be installed at locations to be determined by the Engineer, within or near the project limits, in accordance with the relevant requirements of Section 56-2 of the Standard Specifications and the appropriate details of Standard Plans RS1 through RS4 for two post installation of signs, and as directed by the Engineer.

A reference exhibit displaying the text and colors of the sign will be provided to the Contractor prior to construction. (The Contractor shall submit a copy of the final sign design for approval by the resident Engineer prior to fabrication.)

The Contractor shall submit to the Engineer the final sign design in the form of an editable picture file in .eps format – Encapsulated PostScript file.

At the completion of the project, the signs will become property of the County. When directed by the Engineer, the Contractor shall remove all hardware from the signs. Posts and hardware shall become the property of the Contractor. The Contractor shall deliver and off-load the signs to the address listed below or as directed by the Engineer:

Method of Payment

The contract price paid **per each** for Construction Project Funding Identification Sign shall include full compensation for furnishing all labor, materials, tools, equipment, incidentals and for doing all the work including sign installation, transportation, maintenance, removal, delivery, excavation and backfill as specified in the Standard Specification and these Special Provisions and no additional compensation will be allowed therefor."

Item 5: Water Pollution Control (Santa Ana River Basin-Risk Level 1).

Refer to section entitled "Water Pollution Control (Santa Ana River Basin-Risk Level 1)" and fourth paragraph on page 57. Delete this paragraph and replaced with the following:

"Within **ten (10)** working days after the award of the contract, the Contractor shall submit two (2) copies of the SWPPP/MP to the Engineer for review and approval. The Contractor shall allow **five (5)** working days for the Engineer to review the SWPPP/MP. If revisions are required as determined by the Engineer, the Contractor shall revise and resubmit the SWPPP/MP within three (3) working days of receipt of the Engineer's comments and shall allow **five (5)** working days for the Engineer to review the revisions. The Contractor shall submit four (4) copies of the approved SWPPP/MP to the Engineer prior to notice to proceed. The Contractor must have an approved SWPPP/MP prior to the notice to proceed. The Engineer may provide a letter of conditional approval of the Contractor's SWPPP/MP while minor revisions are made and may allow the Contractor to begin only those certain construction activities identified in the letter of conditional approval. In no case will the conditional approval extend beyond twenty-one (21) calendar days. The Engineer may suspend construction operations until the Contractor submits a revised SWPPP/MP that is reviewed and approved by the Engineer."

Item 6: Grinding Asphalt Concrete in Place.

Refer to section entitled "Grinding Asphalt Concrete in Place." on page 63 through 64. Following additional provision is added and made part hereof:

"At no time will traffic be allowed on pulverized material, base or subgrade. For San Timoteo Canyon Road, each working night, the Contractor will pulverize, grade, compact and place 0.18' HMA leveling course. The final 0.25' lift of HMA shall be placed as the final operation for each street."

Item 7: Roadway Excavation

Refer to section entitled "Roadway Excavation" on page 64. Following additional provision is added and made part hereof:

"At no time will traffic be allowed on pulverized material, base or subgrade. For Live Oak Canyon Road, each working day, the Contractor will excavate compact, place and compact base material and place 0.25' leveling course. The final 0.25' lift of HMA shall be placed as the final operation."

Item 8: Protection and Repair of Existing Irrigation Pipeline

Following Special Provisions are added and made part hereof:

PROTECTION AND REPAIR OF EXISTING IRRIGATION PIPELINE:

Attention is directed to the presence of an active irrigation pipeline that exists within the project limits. The pipeline is understood to be a 12" diameter, non-reinforced PCC pipe that is generally in the shoulder, but does cross Live Oak Canyon Road and San Timoteo Canyon Road. The pipeline is understood to have been installed in the year 1900, and is fragile. The pipeline is understood to be used on a seasonal basis, and may be either active or inactive during the period of construction.

The County of Riverside has made attempts to contact the owner, but without success. The owner is understood to be the Lower Yucaipa Water Company, Art Gregory, President; P.O. Box 830, Redlands, CA 92373; (909) 792-9518.

The contractor shall make every effort to identify the location of the pipeline and protect it in place. In the event that the pipeline is damaged, the Contractor shall:

1. Attempt to contact the owner, as indicated above, and request the owner to inspect the repair work.
2. Excavate and expose the pipe, upstream and downstream of the damaged area.
3. Provide de-watering of soil, and control of irrigation water, as necessary.
4. Cut the pipe, or remove the pipe at a joint.
5. Replace the damaged section of pipe with industry standard pipe and concrete collar, as approved by the engineer.
6. Backfill with select material as directed by the engineer.

Payment for the protection of the irrigation pipeline shall be considered as included in the various items of work, and no compensation will be allowed therefore.

Payment for the repair of the irrigation pipeline will be on a force account basis, in accordance with Section 9-1.03 of the Standard Specifications, up to the fixed bid price, for the work performed.

Item 9: Obtain Encroachment Permit.

Following Special Provisions are added and made part hereof:

"It shall be the responsibility of the Contractor to obtain an Encroachment Permit from the City of Redlands and County of San Bernardino for traffic control plans, if required, and pay all applicable fees required to perform any work done within their Right-Of-Way prior to commencing any work. All work shall comply with the permit.

The Contractor shall submit a request for payments of all fees paid by the Contractor upon completion of all work within the City of Redlands and County of San Bernardino Right-Of-Way. The request shall include copies of all permits and receipts and refund payment documents issued by these agencies.

Method of Payment:

Full compensation for the actual cost of Encroachment Permit fees, as paid by the Contractor to the City of Redlands and County of San Bernardino shall be included in the price paid on force account basis for Obtain Encroachment Permit in accordance with Section 9-1.03 of the Standard Specifications and these Special Provisions, up to the fixed bid price. No markups will be allowed. All incidental costs incurred by the Contractor shall be included in the various items of work, and no compensation will be allowed therefor.

Item 10: Remove and Replace Existing Driveway Approaches.

Following Special Provisions are added and made part hereof:

"Contractor shall remove and replace existing driveway approaches if needed, for smooth transition to new pavement surface with like kind material to match existing driveways as directed by the Engineer.

Method of Payments

Full compensation for removing existing driveway approaches shall be considered as included in the Lump Sum bid price paid for "Clearing and Grubbing" and full compensation for preparing and paving driveway approaches with hot mix asphalt shall be considered as included in the bid price paid for "Hot Mix Asphalt" and shall include furnishing all labor, materials, tools, equipment, incidentals and for doing all the work required to reconstruct existing driveway approaches as directed by the Engineer and as specified in Standard Specification and these Special Provisions and no additional compensation will be allowed therefor."

Item 11: Construction Note 8, Sheets 6, through 10, of 10

Refer to Construction Note No. 8 on plan sheets 6 through 10: Delete and replace with:
"Excavate roadway and place **0.50' HMA over 0.55' AB (CL-2)**"

Item 12: Construction Note 12, All Sheets

Refer to Construction Note No. 12 on all plan sheets: Delete and replace with:
"**Remove and re-construct AC overside drain per Std 306. Match existing down drains**"

Item 13: Clarification to Construction Note 8, for Sheets 8, 9, and 10, of 10

Refer to revised Construction Note No. 8 as shown in item 10 above for plan sheets 8, 9, and 10. Contractor shall apply this construction item to road segment as described below:

Location: 12' Right to 13.5' Right, from Sta 58+06 to Sta. 118+80

Item 14: Clarification to Construction Note 10, Sheets 8, 9, and 10, of 10

Refer to Construction Note No. 10 for plan sheets 8, 9, and 10. Contractor shall apply this construction item to the road segment as described below:

Location: From Sta. 58+06 to Sta. 118+80 Right

Item 15: Construction Note 16, for plan Sheets 2, 8, 9, and 10, of 10

Construction Note 16 is added to the plan sheets 2, 8, 9 and 10 of 10. The description and location of work is described below:

"Remove existing rolled berm and construct **Type E** Mountable Dike per Caltrans Std. A87B."

Location: From 13' Right, Sta. 58+06 to Sta. 118+80

Item 16: Construction Note 17, for Sheets 2, 7, and 8, of 10

Construction Note 17 is added to the plan sheets 2, 7 and 8 of 10. The description and location of work is described below:

"Grind existing pavement to within 1" of flow line, protect existing curb in place"

Location: From Sta. 53+79 to Sta. 58+06 Right.

Item 17: Construction Note 18, All Sheets

Construction Note 18 is added to the all plan sheets. The description of work is described below:

"Reconstruct existing driveway approach to match road improvements. Match existing driveway material and grades, as directed by Engineer."

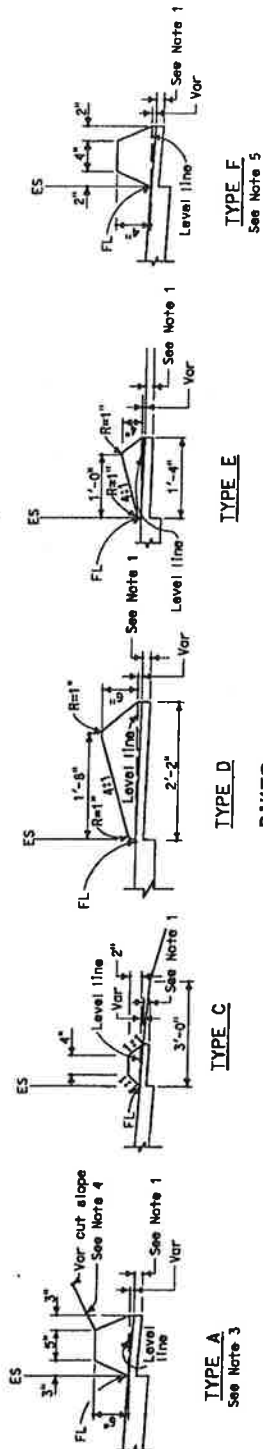

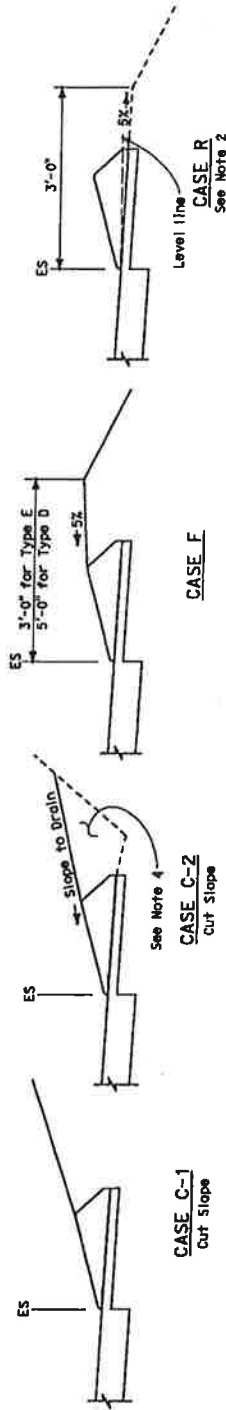
