

Fourth District Use of Community Improvement Designation Funds

BACKGROUND:

Healing Horses is a non-profit organization committed to improving the lives of special needs children and adults throughout the Coachella Valley thru the use of therapy horses. Participants range in ages 2 to 25 and are challenged with Autism, Traumatic Brain Injury, Spina Bifida, Cerebral Palsy, Down's Syndrome, ADH/ADD, Dyslexia and other developmental disorders.

The Friends of the Desert Mountains' Wildflower Festival on March 5, 2011 is an annual family event that will take place at the Santa Rosa & San Jacinto Mountains National Monument Visitor Center.

The Volunteers in Medicine (VIM) Clinic provides medical and dental services to the medically indigent residents of the Coachella Valley. The funding request will offset a portion of the cost to procure ancillary services for patients.

The Galilee Center provides food, clothing and other basic needs for underprivileged and disadvantaged families in Thermal, Mecca North Shore and Coachella. The program goal aims to register 1,000 families to provide food baskets, clothing, and case management.

I would like to use Fourth District Community Improvement Designation funds to support these organizations in fulfilling their missions to provide services to the residents of the Coachella Valley.
