**RECOMMENDED MOTION:** That the Board Approves and

**BACKGROUND:** The Redlands Bicycle Classic (Classic) would like to have access to Bogart Park for Stage 1 of the Classic on April 1, 2011. The route for the race is scheduled to go through the community of Cherry Valley and portions of the cities of Beaumont and Banning. Part of the Stage 1 race course will go through Bogart Park. The race will have minimal impact to the park, and it is an ideal location for the event. The District would like to support this stage of the race as it is a good opportunity to showcase the attributes of Riverside County as part of the Classic.


