7 The Board of Supervisors of the County of Riverside ordains as follows:

8 Section 1. Section 4. of Ordinance No. 884 is amended to read as follows:

9 “Section 4. PROHIBITION. No person shall engage in targeted picketing
10 within three (3) feet of the property (measured from the property line) upon which the
11 targeted residential dwelling is located.”

12 Section 2. This ordinance shall take effect thirty (30) days after its adoption.

RECOMMENDED MOTION: That the Board of Supervisors introduce and adopt Ordinance No. 884.1 on successive weeks.

BACKGROUND: On February 8, 2011, the Board of Supervisors adopted an order initiating an amendment to Ordinance No. 884 that would reduce from thirty (30) to three (3) feet the distance within which targeted residential picketing is prohibited. The Board also directed the Office of County Counsel to prepare and process the amendment. Ordinance No. 884.1 has been prepared in accordance with that directive.
