BACKGROUND:

The District, in cooperation with the Corps of Engineers, is currently designing Murrieta Creek Phase I ("Project") which travels through the city of Temecula. The City of Temecula ("City") is currently acquiring, in cooperation with the District, all required right-of-way for this Project within the City's limits. Pursuant to the preliminary design for the Project, a Record of Survey was prepared and recorded in Book 114 Pages 95 through 99. The City of Temecula owned RCFC Parcel 7021-16 as described on the Record of Survey. The City had conveyed via Grant Deed, recorded as Instrument Number 2004-0381206 on May 20, 2004, the fee title to the District. The District then issued a letter of credit to the City for the appraised value. Upon further design it was determined that the District would not need all the original right-of-way dedicated for the Project.

The City has proposed to build a recreational complex which is a compatible use adjacent to Murrieta Creek Phase I. The District has reviewed and approved the plans for the recreational complex. A portion of RCFC Parcel No. 7021-16, and a small portion of the adjacent Parcel No. 7021-15 is needed for the recreational complex. The District will retain a blanket access easement across said parcels for ingress/egress to Murrieta Creek Phase I.

The District recommends that the right-of-way referenced as RCFC Parcel Nos. 7021-16A and 7021-15A, shown on Exhibits "A" and "B", consisting of approximately 28,625 sq/ft, be granted in fee title to the City of Temecula. The original value established in 2004 for the District's acquisition of RCFC Parcel No. 7021-16 was \$2.50 a sq/ft. The District will issue a reversal of a portion of the credit given to the City of Temecula in the amount of \$71,563. All other costs shall be borne by the City of Temecula.
