

BACKGROUND:

The San Jose Community & Bea Main Learning Center is a non-profit organization. The organization will be presenting their Fifth Annual Luncheon on April 14th to raise operational funds for an after school program located in the unincorporated community of Oasis.

Building Healthy Communities Eastern Coachella Valley is hosting a Youth Arts & Culture Event that will showcase the talent and creativity of youth in the eastern Coachella Valley. The event is scheduled to take place on April 9th and will feature music, games, arts, culture, vendors and family activities.

The Dr. Reynaldo Carreon Foundation's 20th Anniversary Student Awards Banquet on May 14th will recognize recipients of previous years and this year's scholarships. The Foundation has awarded more than \$1 million in scholarships through the years to underprivileged students of Mexican descent who are in pursuit of higher education.

Working Wonders' "From High-Risk to Mainstream" program is one of a few non-school based programs designed to target high risk-youth and youth offenders. Working Wonders works with the Riverside County Department of Probation, Youth Division.
