BACKGROUND: Government Code § 25845, Riverside County Ordinance Nos. 457 (RCC Title 15) and 725 (RCC Chapter 1.16) and Section 1618, Article 10, Title 25 of the California Code of Regulations, provide authority for the recovery of abatement costs in public nuisance cases, the recordation of a notice of abatement lien and inclusion of abatement costs on the tax roll as a special assessment upon approval of the Board of Supervisors.

With regard to Case No. CV08-04756, a Ten-Day Notice of Intent to Abate Substandard Mobile Home was issued on Oct. 14, 2009. On or about Aug. 20, 2010, the substandard mobile home was voluntarily abated by the property owner and the case was closed. Additionally, with regard to Case No. CV09-09595, the Board of Supervisors issued an Order to Abate in this case on Feb. 23, 2010 and recorded on Feb. 25, 2010, as document number 2010-0086921. Subsequently, the property owner voluntarily removed the accumulated rubbish.


