2. Authorize the Chairman to execute the Agreement documents on behalf of the District.

**BACKGROUND:**

The Agreement transfers the rights and responsibilities as established by the original Cooperative Agreement executed on January 10, 2006 (Board Agenda Item No. 11.13), from the Assignor to the Assignee. Once the Agreement is executed, the Assignee will complete the construction of the drainage facilities necessary for Tract Nos. 30696-1, 30696-3 and 30696-4.

**BACKGROUND:**

The Agreement is necessary to provide for District construction inspection of the referenced facilities associated with Tract Nos. 30696-1, 30696-3 and 30696-4.

Upon completion of the facilities' construction, the District will assume ownership, operation and maintenance of the facilities except for catch basins, laterals and connector pipes which are to be maintained by the County.

County Counsel has approved the Agreement as to legal form. A companion item appears on the County's Agenda this same date.

The Assignee is funding all construction and construction inspection costs.

**ASSIGNMENT AND ASSUMPTION AGREEMENT**

Warm Springs Valley – Evening Glow Drive Storm Drain, Stage 2  
Project No. 7-0-00219-2  
(Tract Nos. 30696-1, 30696-3 and 30696-4)

This ASSIGNMENT AND ASSUMPTION AGREEMENT, hereinafter called "ASSIGNMENT", is made by and between (i) the RIVERSIDE COUNTY FLOOD CONTROL AND WATER CONSERVATION DISTRICT, hereinafter called "DISTRICT"; (ii) the COUNTY OF RIVERSIDE, hereinafter called "COUNTY", (iii) LENNAR SPENCER'S CROSSING, LLC, a Delaware limited liability company, hereinafter called "ASSIGNOR", and (iv) RIVERSIDE MITLAND 03 LLC, a Delaware limited liability company, SPENCER'S CROSSING 103, LLC, a Delaware limited liability company, and RICHMOND AMERICAN HOMES OF MARYLAND, INC., a Maryland corporation, hereinafter together called "ASSIGNEE".

**RECITALS**

A. DISTRICT, COUNTY and ASSIGNOR have previously entered into that certain Agreement which was executed on January 10 2006, and recorded as Document No. 2006 – 0054189 in the Official Records of the County of Riverside and is hereinafter called "AGREEMENT", setting forth the parties' respective rights and obligations concerning ASSIGNOR'S proposed design and construction of certain flood control and drainage facilities required as a condition of approval for Tract Nos. 30696-1, 30696-3 and 30696-4 located in the County of Riverside, State of California (hereinafter, the "PROPERTY"); and

B. Subsequent to the execution of said AGREEMENT, ASSIGNEE has acquired fee title to the PROPERTY; and

C. A true copy of AGREEMENT has been provided to ASSIGNEE and said AGREEMENT describes the terms and conditions by which those certain flood control and drainage improvements that are required in connection with the development of Tract Nos. 30696-1, 30696-3 and 30696-4 are to be designed and constructed by ASSIGNOR, and inspected and accepted for operation and maintenance by DISTRICT and COUNTY; and

1 D. AGREEMENT stipulates that ASSIGNOR may assign its rights and  
2 responsibilities as set forth therein subject to the written consent of the parties thereto; and

3 E. The totality of ASSIGNOR's rights, title, interests, benefits and privileges pursuant  
4 to AGREEMENT are hereinafter collectively called "ASSIGNOR RIGHTS" and the totality of  
5 ASSIGNOR's obligations pursuant to AGREEMENT are hereinafter collectively called  
6 "ASSIGNOR OBLIGATIONS"; and

7 F. ASSIGNOR RIGHTS and ASSIGNOR OBLIGATIONS are hereinafter altogether  
8 called "RIGHTS AND OBLIGATIONS"; and

9 G. ASSIGNOR, ASSIGNEE, COUNTY and DISTRICT intend that, by execution of  
10 this ASSIGNMENT, ASSIGNEE shall assume all of ASSIGNOR RIGHTS AND  
11 OBLIGATIONS.

12 NOW, THEREFORE, the parties hereto do hereby mutually agree as follows:

13 1. The above Recitals are true and correct.

14 2. By execution of this ASSIGNMENT, ASSIGNOR hereby assigns all of their  
15 RIGHTS AND OBLIGATIONS to ASSIGNEE.

16 3. For the benefit of COUNTY and DISTRICT, ASSIGNEE hereby ratifies and  
17 agrees to be bound by the assignment of RIGHTS AND OBLIGATIONS set forth in Paragraph 2  
18 above.

19 4. ASSIGNEE agrees to complete construction of PROJECT and  
20 APPURTENANCES as detailed in AGREEMENT within twelve (12) consecutive months after  
21 execution of this Agreement and within one hundred eighty (180) consecutive calendar days after  
22 commencing work on PROJECT and APPURTENANCES.

23 5. In regard to the assignment of RIGHTS AND OBLIGATIONS set forth herein,  
24 COUNTY and DISTRICT hereby consent to and hereby agree to be bound by (i) the assignment  
25 of RIGHTS AND OBLIGATIONS in favor of ASSIGNEE, and (ii) the assumption by  
26 ASSIGNEE of said RIGHTS AND OBLIGATIONS. In further clarification of the intent of the  
27 parties, ASSIGNEE and ASSIGNOR specifically agree with DISTRICT that access and/or grant  
28

1 of real property interests required by DISTRICT pursuant to AGREEMENT, if any, shall be  
2 satisfied by ASSIGNEE, and in regard to all financial obligations, DISTRICT shall invoice  
3 ASSIGNEE for all charges incurred pursuant to AGREEMENT.

4 6. The assignment and assumption of RIGHTS AND OBLIGATIONS pursuant to  
5 this Assignment shall be binding upon and inure to the benefit of the successors, assigns, personal  
6 representatives, heirs and legatees of the respective parties hereto.

7 7. In the event that any action or suit by the party hereto is brought against another  
8 party hereunder by reason of any breach of any of the covenants, conditions, agreements or  
9 provisions on the part of the other party arising out of this ASSIGNMENT, the prevailing party  
10 shall be entitled to have and recover of and from the other party all costs and expenses of the  
11 action or suit, including reasonable attorneys' fees.

12 8. This ASSIGNMENT shall be governed by, interpreted under and construed in  
13 accordance with the laws of the State of California.

14 9. Any and all notices sent or required to be sent to ASSIGNOR or ASSIGNEE  
15 arising from either this ASSIGNMENT, or the obligations contained in AGREEMENT will be  
16 mailed by first class mail, postage prepaid, to the following addresses:

12. This ASSIGNMENT may be executed in multiple counterparts, each of which shall be deemed an original, but all of which together shall constitute but one and the same instrument.


