3. Ratify Change Order No. 4 in the amount of \$26,206 and find that it was impractical to bid out the additional work based on the integral nature of the work as presented in the background facts;
4. Authorize the Assistant County Executive Officer/EDA, or designee, to execute the change order on behalf of the county;
5. Approve the reduction of the contract retention for Orr Builders from 10% to 5% per the general Conditions of the contract and authorize the release of \$138,777 in retained funds to the contractor in accordance with the contract terms; and
6. Accept the Blythe Fleet Services Fueling Station and Car Wash constructed by Orr Builders as completed and authorize the Clerk of the Board to record the Notice of Completion.

BACKGROUND:

On September 30, 2008, the Board of Supervisors approved an architectural services agreement between the County of Riverside and Holt Architects in the amount of \$122,770 for design services of the Blythe Fleet Services Fueling Station and Car Wash.

Additional tasks requested by the City of Blythe and the County of Riverside were not included in the original scope of work within the contract. As a result of these additional services, Amendment No. 1 will compensate Holt Architects in the amount not-to-exceed \$7,108.

On December 22, 2009, the Board of Supervisors approved the construction contract between the County of Riverside and Orr Builders in the amount of \$1,239,500 for construction of the Blythe Fleet Services Fueling Station and Car Wash.

Change Order No. 4 will exceed the 10% contingency allowance, which requires Board approval. The change order will compensate Orr Builders in the amount not-to-exceed \$26,206.

Construction costs for the Blythe Services Fueling Station and Car Wash exceeded the 10% contingency due to an excessive amount of water in the ground. For these areas, we were required to determine the extent of the leaks and to identify the source. The work performed under Change Order No. 4 was essential to the successful completion of the project. Furthermore, the scope of this work was interrelated with the base scope of the contractor, making the work performed under Change Order No. 4 impractical to bid out.

The general conditions of the contract state that after the 50% completion point of the contract work, if satisfactory progress is being made, the county has sole discretion to reduce the retention to a minimum of 5% of the contract. Orr Builders has completed the work on time, within budget, and in a professional manner. Therefore, the Economic Development Agency recommends that the contract retention be reduced to 5% of the contract and the Clerk of the Board to record the Notice of Completion.

BACKGROUND: (Continued)

The project was inspected and found to comply with all contract requirements. This Board action will release \$69,389, which is 5% of the total contract, and the remaining retention funds of \$69,388 to Orr Builders. The sum of these two amounts is \$138,777.

Sufficient funds are budgeted for FY 2010/11 within the project budget to cover all costs associated with this agreement. This agreement will be fully funded by Fleet Services, thus no additional net county costs will be incurred as a result of this agreement.



AMENDMENT NO. 1

To The
AGREEMENT

THE COUNTY OF RIVERSIDE AND HOLT ARCHITECTS, INC.

The County of Riverside and Holt Architects, Inc. of Rancho Mirage, CA hereby agree to amend that certain agreement for Architectural Services associated with the Blythe Fleet Services Fueling Station and Car Wash (FM08730003903) approved on 9/30/08, Agenda Item 3.44 as follows:

- Section II. SCOPE OF SERVICES shall be modified in the first paragraph to read as follows:

“ARCHITECT shall provide additional services as outlined and specified in **Exhibit A-1** consisting of 1 page attached hereto and incorporated herein by this reference”.

- Section III. ARCHITECT’S SERVICES shall be modified to add the following sentence to the introductory paragraph:

“The term of this Agreement shall be from September 30, 2008 and continue in effect until the Blythe Fleet Services Fueling Station and Car Wash is complete, unless terminated as specified in Paragraph X.A. All applicable indemnification provisions in this Agreement shall remain in effect following the termination of this Agreement.”

- Section VI. COMPENSATION, subparagraph A.4 to be modified as follows:

“Authorized reimbursable expenses shall be paid at consultant’s cost, plus 10%. Authorized reimbursable expenses are as follows, and shall not exceed: \$9,107.86.”

- All other terms and conditions of the agreement shall remain in full force and effect.
