This Fifth Amendment increases the professional services coverage for vascular interventional radiology along with vascular surgical procedures that must be provided at the Hospital on an emergency basis.

FIFTH AMENDMENT
TO THE
PROFESSIONAL SERVICES AGREEMENT
BETWEEN
COUNTY OF RIVERSIDE
AND
LOMA LINDA UNIVERSITY HEALTHCARE

That certain Agreement between the County of Riverside ("COUNTY") and Loma Linda University Healthcare ("CONTRACTOR") dated January 1, 2006 and amended September 5, 2006, March 16, 2007, January 1, 2010, and August 1, 2010 is hereby further amended effective March 1, 2011 pursuant to the following:

1. Delete the first sentence of Section 1.2 A. and replace with the following:

"A. Provide adequate staffing to assume medical care responsibilities for general surgery, critical care-intensivist program, vascular interventional radiology and vascular coverage for nights, weekends, and holidays under the direction of the Chief of the HOSPITAL Department of Surgery (DEPARTMENT) and the HOSPITAL Medical Director."

2. Delete the first sentence of Section 1.0, Exhibit A and replace with the following:

"1.0 Subject to the conditions set forth below, HOSPITAL shall pay CONTRACTOR for the services of five and one-half (5 ½) FTE attending physicians from the CONTRACTOR's Medical Group to provide administrative, supervisory, teaching services, direct patient care professional general surgery, interventional radiology and vascular coverage for nights, weekends, and holidays, inpatient critical care intensivist coordination and oversight, ambulatory surgery, and outpatient clinical services to be provided at HOSPITAL in accordance to the fee schedule(s) listed below."

3. The language of Exhibit A, Section 3 is deleted in its entirety and replaced as follows:

"Maximum annual compensation payable under this Agreement shall not exceed one million nine hundred eighty-nine thousand, six hundred dollars (\$1,989,600)."

All other terms and conditions of this Agreement are to remain unchanged.
