2. Authorize the Chairman to execute the Agreement documents on behalf of the County.

BACKGROUND: The Agreement transfers the rights and responsibilities as established by the original Cooperative Agreement executed on January 10, 2006 (Board Agenda Item No. 11.13), from the Assignor to the Assignee. The Assignee will complete the construction of the drainage facilities necessary for Tract Nos. 30696-1, 30696-3 and 30696-4.

The Assignee will fund all construction and inspection costs.

The County Transportation Department is granting the Assignee the necessary rights-of-way to construct the project within County road right-of-ways and, upon completion of project construction, the County will assume ownership, operation and maintenance of the Storm Drain Appurtenances, including catch basins, connector pipes and storm drain segments that are 36-inches or smaller in diameter. The District will be responsible for the operation and maintenance of the Storm Drain.

County Counsel has approved the Agreement as to legal form. A companion item appears on the Flood Control District's agenda this same date.
