SUBJECT: ERACE Program (Eliminate Registrant Attendance at County Entities)

RECOMMENDED MOTION: To direct County Counsel to create and initiate an ordinance to support the ERACE Program.

BACKGROUND: Riverside County is home to over 3500 sexual registrants, many are dangerous sexual predators. Current ordinances only place limits on where these sexual registrants can live *relative to* places where children congregate, but they do **not** restrict where a Registrant can loiter at any given time. This potential ordinance will restrict sexual registrants from being on any Riverside County property where children may congregate and hence further protect our youth from becoming potential victims of a registrant's heinous activities. I am requesting that the Board of Supervisors join me in directing County Counsel to draft an ordinance that accomplishes the following:

- 1. Prohibiting sexual registrants from being in or on any County property or facility where children may congregate, including but not limited to:
 - All County Parks, Recreation Centers, Aquatics Centers, etc. These facilities shall be clearly identified in the proposed ordinance by name and location.
 - B. All County sponsored public events on County Property where children may be present, including but not limited to: Riverside County Date Festival, Temecula Balloon and Wine Festival, County Air Shows, Film Festivals, Fairs, Parades, etc.
 - C. Prohibiting any dwelling unit within the County of Riverside that houses a registered sex offender from participating in Halloween or any other holiday which allows the sexual registrant to use an "attractive nuisance" to gain contact with children.
 - D. Exception to this ordinance: This ordinance shall not restrict a sexual registrant from mandatory and timely "registering" at the appropriate County facilities where a child may be present e.g. Sheriff's Station, in accordance with State or Federal Law.
