**BACKGROUND:**

In 2001, the Probation Department (Probation) built a new Juvenile Hall detention facility next to the Southwest Justice Center. Due to budget constraints at the time, Probation was limited to the number of cameras they were able to install and the type of video technology used.

Southwest Juvenile Hall's camera surveillance system is now outdated and is no longer adequate to support the needs of the facility or Probation. The current camera system is an antiquated analog system. Because the system is out-dated, additions and repairs are no longer possible as replacement parts are no longer available. The approval of this project would allow Probation to replace and expand their existing system with new digital cameras and increase the recording speeds to give near fluent record motion with crisp, clear images and would be able to meet the one year recorded storage requirement. Part of this project would also be to remodel a storage room turning it into a new server room for the system as well as remodeling the control center to accommodate a new large format monitoring system.

It is critical for the safety, security, and monitoring of this facility to be able to capture, record, and replay details of incidents clearly and in real-time, which the proposed new system will allow.

Approval of this agenda item will authorize EDA to proceed with the project.

Sufficient funds are budgeted for FY 2010/11 to cover all costs associated with this agreement. This agreement will be funded by Capital Improvement-General Fund Designation funds in the amount of \$200,000 and by Probation Department Funds in the amount of \$465,000, therefore no additional net county cost will be incurred as a result of this agreement.
