BACKGROUND:

The United States Department of Housing and Urban Development (HUD) requires that all substantial amendments to the Five-Year Consolidated Plan and the One-Year Action Plan be approved by the Board of Supervisors. All new activities added to the One-Year Action Plan, as well as a significant increase in funding to an existing project or changes to the scope or nature of an existing project, will be considered substantial amendments. Pursuant to 24 CFR 91.105, the Economic Development Agency published a 30-day public notice on April 2, 2011 notifying the public of the proposed amendment to the County of Riverside 2010-2011 One-Year Action Plan and the 2009-2014 Five-Year Consolidated Plan. Staff recommends approval of the new HOME project as described in Attachment "A."

Project Description:

Coachella Valley Housing Coalition (CVHC), a non-profit public benefit corporation, has applied for \$600,000 in HOME funds for the development and construction of 11 new single family homes for low income families in the unincorporated community of North Shore.

The proposed project will consist of 11 new homes that will be built through the mutual self-help construction method on 11 scattered residential lots located in an existing urban residential neighborhood. The proposed project will consist of 11 four-bedroom homes, each averaging approximately 1,320 square feet.

The homes will be sold to families whose incomes are no more than 80% of the Area Median Income.

CVHC intends to use up to \$600,000 in HOME funds for hard and soft construction expenses. Other funding sources that are being sought by CVHC include a \$784,000 loan from US Department of Agriculture, a \$74,000 grant from the Farmworker Housing Grant, and \$82,000 from an Affordable Housing Program source. The total development costs are estimated to be \$1,540,000.
