SUBJECT: Resolution of the Board of Supervisors in support of the Los Angeles Football Stadium at Grand Crossing.

RECOMMENDED MOTION: That the Board of Supervisors join us in adopting Resolution No. 2011-131 in support of the Los Angeles Stadium at Grand Crossing.

BACKGROUND: The stadium project will generate over 18,000 jobs at a time when the citizens of our region are eager to get back to work. The project's 600 acres totals 2,985,000 square feet, which will include a state-of-the-art NFL stadium and office, retail and themed entertainment destinations.

This project will be privately funded and will be a shot-in-the-arm to our region by generating \$762 million in annual economic output, without burdening taxpayer's with cost. It will also generate over \$21 million in fiscal benefits to the taxable authorities of the region. This resolution will assist in supporting this project.

5 **A RESOLUTION OF THE COUNTY OF RIVERSIDE IN SUPPORT OF**
6 **THE LOS ANGELES FOOTBALL STADIUM AT GRAND CROSSING**

8 **WHEREAS**, professional football is an American pastime that is enjoyed by Riverside
9 County residents; and
10

11 **WHEREAS**, our region has been without a professional football team for over a
12 decade; and
13

14 **WHEREAS**, a new stadium will need to be built to accommodate a new professional
15 football team; and
16

17 **WHEREAS**, two stadium proposals, the Los Angeles Stadium at Grand Crossing and
18 another in downtown Los Angeles, are being considered for a potential new professional
19 football team; and

21 **WHEREAS**, the Los Angeles Football Stadium at Grand Crossing is being financed
22 solely through private funds and without any public money, while the downtown Los Angeles
23 stadium proposal would require at least \$350 million in municipal bonds; and

1 **WHEREAS**, the Los Angeles Football Stadium at Grand Crossing would generate
2 18,000 regional jobs that could provide employment to Riverside County residents and
3 hundreds of millions of dollars in economic benefit for the entire region; and

5 **WHEREAS**, the Los Angeles Football Stadium at Grand Crossing has committed to
6 environmental sustainability by building to Leadership in Energy & Environmental Design
7 standards and utilizing solar power and reclaimed water; and
8

9 **WHEREAS**, the Los Angeles Stadium at Grand Crossing has passed all environmental
10 approvals and is shovel ready while a stadium in downtown Los Angeles would require
11 significant environmental review that could take years to complete and would create
12 environmental hazards that would not be able to be mitigated; and
13

14 **WHEREAS**, the Los Angeles Football Stadium at Grand Crossing is located at a
15 central location in Southern California that is easily accessible to fans of Riverside County;
16 and

18 **WHEREAS**, the Los Angeles Football Stadium at Grand Crossing is at the crossroads
19 of two major freeways and will not suffer from downtown Los Angeles gridlock; and
20

21 **NOW, THEREFORE, LET IT BE RESOLVED, that the Riverside County Board**
22 **of Supervisors strongly endorses the Los Angeles Football Stadium at Grand Crossing**
23 **and believes that this stadium provides the best location and venue for professional**
24 **football for Riverside County residents.**
