BACKGROUND:

The RCRMC Foundation is seeking to assist Riverside County in increasing access to primary care services in underserved communities within the county. To address this need, it has purchased a mobile health clinic vehicle at a cost of approximately \$419,000. The vehicle was purchased primarily through funds raised from the RCRMC Foundation's KB Home Golf Classic. The RCRMC Foundation will maintain ownership of the vehicle. RCRMC, on behalf of Riverside County, will operate the mobile health clinic program and be responsible for all program-related costs.

RCRMC was recently awarded a grant from HRSA for the purchase of a mobile health clinic vehicle. It is proposed that this grant be transferred to the RCRMC Foundation to be used towards payment of the mobile health clinic vehicle.

This mobile health clinic program will serve as an extension of the school and community-based clinics outreach program authorized by Board of Supervisors approval on July 21, 2009 (Agenda Number 3.73). A range of primary and preventive care and health education services will be provided to low income individuals and families in communities throughout Riverside County.
