SUBJECT: Summarily vacating a portion of Clark Street and execution of Quitclaim Deed, in the Mead Valley area, First Supervisorial District.


RECOMMENDED MOTION: Adopt Resolution No. 2011-007 summarily vacating a portion of Clark Street, and authorize the Chairman to execute the Quitclaim Deed.

BACKGROUND: The portion of the original alignment of Clark Street east of Columbia Elementary School is now excess right-of-way and no longer required for right of way purposes. The right-of-way being vacated along with a previously vacated portion of Clark Street is owned in fee title by the County of Riverside and requires the execution of a quitclaim deed to pass title to the Val Verde Unified School District. The street improvements provided by the school district along Clark and Rider Streets are of equal to or greater value than the existing fee right-of-way, therefore no compensation is necessary. This vacation will not eliminate access to any parcel.



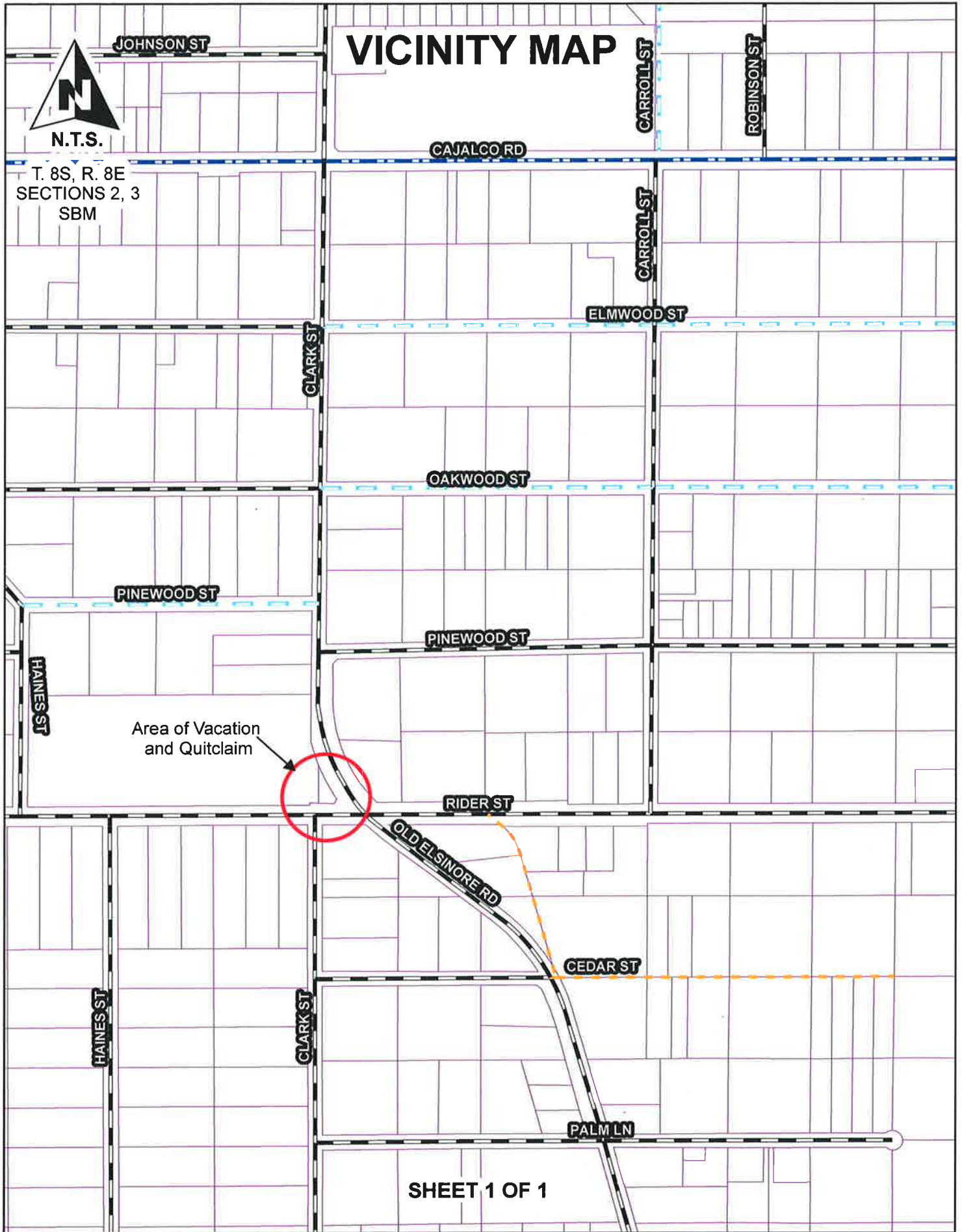

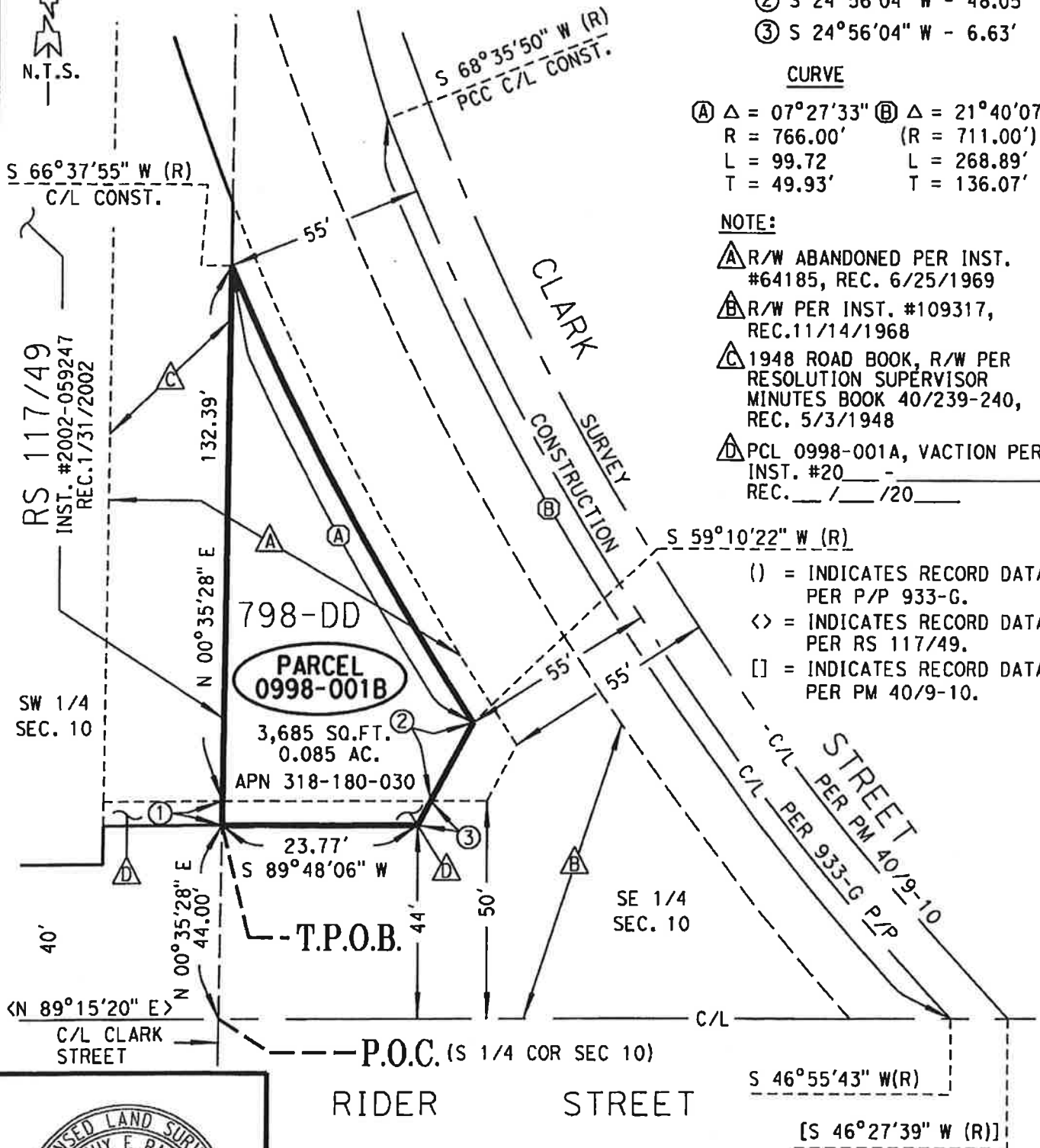
