SUBJECT: Letter of Intent regarding Request for Revocation of the Eligible Scenic Highway

Designation for a 1.12 mile section of Interstate 10 in Cabazon

RECOMMENDED MOTION: That the Board of Supervisors execute the letter of intent, requesting Caltrans revoke the Eligible Scenic Highway designation for a 1.12 mile section of Interstate 10 in Cabazon and authorize the Chairman of the Board to sign.

BACKGROUND: California's Scenic Highway Program was created by the Legislature in 1963. The purpose of the Scenic Highway Program is to protect and enhance the natural scenic beauty of California highways and adjacent corridors, through special conservation treatment. A highway may be designated scenic depending upon how much of the natural landscape can be seen by travelers, the scenic quality of the landscape, and the extent to which development intrudes upon the traveler's enjoyment of the view.

Highways listed in the State Scenic Highway System are either eligible for designation as scenic highways or have been officially designated. The status of a proposed scenic highway changes from "eligible" to officially "designated" when the local governing body applies to Caltrans for scenic highway approval, adopts a Corridor Protection Program, and receives notification that the highway has been officially designated a Scenic Highway.


Currently, the State Scenic Highway system includes Interstate 10 (Route 10) from Route 38 near Redlands to Route 62 near Whitewater. This I-10 corridor is eligible for designation as a scenic highway but has not been officially designated.

A small stretch of this I-10 corridor no longer meets the State Scenic Highway standards due to nearby development on the Morongo Indian Reservation and in the County. The section of highway is from the Fields Road exit (post mile 16.54), which is also the eastern boundary of the City of Banning, heading easterly to the Apache Trail exit (post mile 17.66) for a total length of highway of 1.12 miles. Given the amount of development at the Cabazon Outlets and Morongo Casino on the north side of I-10 and visual intrusions including railroad tracks, an active gravel pit and numerous existing billboards on the south side of this 1.12 miles section, this area should no longer be included on the scenic eligible list.

As previously stated this particular corridor has not been officially designated, but there is no process outlined for removing an eligible section; therefore, the County is proceeding through the process as if the section has been officially designated. The process is as follows: A Board of Supervisors may request that Caltrans revoke a designated scenic highway within its jurisdiction at any time so long as the revocation request is placed on the Board's agenda at a public meeting to allow public input. A letter of intent by the Board must then be submitted to the District Scenic Highway Coordinator.

The proposed letter of intent requests only that the 1.12 mile stretch of I-10 be de-designated. It does not affect any other highways in the County. Nor does it alter any General Plan policies or County ordinances. Once this portion of highway is de-designated, any proposed offsite outdoor advertising displays would still need to go through the Caltrans and County permitting and entitlement process. In addition, the potential for future public safety messaging displays would be a valuable benefit to the general public for emergency communications.

Dear Mr. Cadd:

Currently, the State Scenic Highway system includes Interstate 10 (Route 10) from Route 38 near Redlands to Route 62 near Whitewater. This I-10 corridor is eligible for designation as a scenic highway but has not been officially designated.

A small stretch of this I-10 corridor no longer meets the State Scenic Highway standards due to nearby development of the Morongo Indian Reservation and in the County of Riverside. This section of highway is from the Fields Road exit (post mile 16.54), which is also the eastern boundary of the City of Banning, heading easterly to the Apache Trail exit (post mile 17.66) for a total length of 1.12 miles. Please see the enclosed map for the specific location.

Given the amount of development at the Cabazon Outlets and Morongo Casino on the north side and visual intrusions including railroad tracks, an active gravel pit and numerous existing billboards on the south side of this 1.12 miles section, this area should no longer be included on the scenic eligible list.

The County of Riverside hereby requests that Caltrans remove the "eligible" scenic highway designation from this 1.12 mile section of Interstate 10 from Fields Road exit to Apache Trail exit. Due to moderate intrusion of commercial/retail development and industrial activities, the character of the area no longer meets the scenic highway criteria.
