### **BACKGROUND** (Continued):

On April 22, 2008, the Board approved Child Abuse Prevention, Intervention and Treatment (CAPIT), Promoting Safe and Stable Families (PSSF), and Community-Based Child Abuse Prevention (CBCAP) funding recommendations to provide core services, including: Anger Management; Domestic Violence; Counseling; In-Home Visitation; Parenting Education; Adoption Support

In 2001, the California Legislature passed AB 626 (Chapter 678) enacting the Child Welfare Outcomes and Accountability Act, which requires counties to provide a tri-annual System Improvement Plan. The California Department of Social Services (CDSS) has requested that each county align the CAPIT/PSSF funding cycle with the System Improvement Plan (SIP), County Needs Assessment and Peer Quality Case Review (PQCR).

In an effort to maintain continuity, DPSS requests extending all core service agreements one (1) additional year, for a total of four (4) renewals to ensure the CAPIT/PSSF/CWSOIP funding cycle aligns the with 2012-2015 County SIP.

**FINANCIAL:** Funding for these contracts is 100% State and Federal funds and was budgeted through the normal County budget process.
